
Who Holds the Power? Nigeria's Shifting Political Alliances

s Nigeria's political stage heats up, the nation is witnessing a wave of shifting alliances that could redefine its power dynamics. In a landscape where loyalty often bows to opportunity, political heavyweights and rising stars alike are recalibrating their positions ahead of pivotal elections. The question dominating conversations across the country is clear: who truly holds the power?

Recent defections, coalition talks, and behind-thescenes negotiations suggest that Nigeria's political structure is in flux. Legislators from both the ruling and opposition camps have been crossing party lines, spurred by discontent, strategic positioning, or the search for greener pastures. For many, these movements are less about ideology and more about political survival in an unpredictable environment.

At the heart of this shifting landscape is the ruling party, which faces growing internal rifts. High-profile disagreements over key policies such as subsidy removal, rising inflation, and the ongoing fuel crisis have exposed cracks in the party's unity. While it con-



tinues to maintain a legislative majority, murmurs of discontent from party faithful and regional leaders hint at potential fractures that could impact its future.

Meanwhile, the opposition appears emboldened by public frustration with the current administration. However, unity remains a challenge. Efforts to forge a mega-coalition are underway, but deep-seated rivalries and competing ambitions have slowed progress.

"The opposition has an nience." opportunity to seize power, but only if it can present a united front," said political analyst Dr. Aisha Garba. "Right now, they are still working out the terms of their marriage of conve-

Regional dynamics further complicate the picture. In the south, governors and political leaders are consolidating their influence, aiming to challenge northern dominance in national poli-

tics. In the north, traditional rulers and political stalwarts are leveraging their cultural and religious authority to maintain their hold on power. These regional power plays highlight Nigeria's enduring struggle to balance national unity with diverse local interests.

Amid these shifts, the electorate is growing restless. Many Nigerians view the ongoing realignments as a distraction from urgent national issues, including insecurity, unemployment, and worsening economic conditions. "The politicians are busy playing games while ordinary people are suffering," lamented a civil servant in Kaduna. "We need leaders who care about the people not just their the people, not just their next election." said Abubakar Musa.

As the 2027 elections draw closer, the stakes are higher than ever. Both the ruling party and the opposition understand that their future hinges on these shifting alliances. The question remains: will these political maneuvers lead to meaningful change, or will they perpetuate the cycle of selfinterest that has defined Nigerian politics for decades?

Who Holds the Power? Nigeria's Shifting Political Alliances

For now, the chessboard is set, and the players are making their moves. Nigerians can only watch and hope that the eventual vic $tors\,will\,wield\,their\,power\,in$ service of the nation, not just themselves.

Speaking on this development, a Political Analyst, John Atabo said; "with the 2027 general elections on the horizon, the question of who holds the power has never been more pertinent. In my analysis, what we are witnessing is not merely a series of defections, but a fundamental recalibration entrenched influence in the of Nigeria's political dynamics, where the lines between the ruling party, opposition, and regional interests are becoming increasingly

According to him, "most striking feature of Nigeria's political realignment is the intensifying fragmentation within the ruling party. Despite its hold on power, the ruling party faces a growing number of internal divisions, largely driven by dissatisfaction with the administration's handling of critical issues such as fuel subsidy removal, the state of the economy, and rising insecurity. These fractures are not just about policy disagreements; they reflect deeper tensions over the distribution of power, resources, and influence within the party itself. As the leadership struggles to maintain a united front, defections from within the party are inevitable. Several key figures, sensing the shifting winds, have begun to reposition themselves for the upcoming electoral cycle, either by distancing themselves from the administration or seeking new alliances with other political forces.'

However, he continued, "the opposition, while opportunistic, faces its own set of challenges. Despite the growing discontent with the current government, the opposition has failed to present a cohesive and unified alternative. Instead, we see political fragmentation with competing factions vying for dominance. The recent efforts to form coalitions, aimed at challenging the ruling party in 2027, have been hampered by personal rivalries, divergent regional interests, and ideological differences. Unlike in past elections, where opposition parties were merely reactive, the current environment demands that they evolve into a credible, unified force capable of offering a clear policy agenda to the Nigerian electorate. Without that cohesion, the opposition risks being nothing more than a collection of

The regional dynamics also cannot be ignored. In Nigeria, political power is often tied to geographical influence, and the shifting alliances we are witnessing are a reflection of this reality. Southern leaders, frustrated by the perceived marginalization of their region, are consolidating power to assert their political relevance, particularly with the 2027 elections in mind. Similarly, northern power brokers are holding firm, leveraging their nation's political and economic sectors. These regional power plays are shaping alliances and reshaping party affiliations in ways that are not easily predictable. As such, the role of traditional rulers, governors, and ethnic groups cannot be downplayed in the determination of who will ultimately hold the power."

He pointed out that "to the average Nigerian, these shifting alliances raise legitimate concerns. There is growing frustration over the self-serving nature of political elites, with many feeling disconnected from the real issues affecting the country, such as insecurity, unem-ployment, and inflation. of critical issues such as eco-political spectrum, the oppo-sition is eagerly eyeing these

pied with maneuvering for power, appears to have lost sight of the urgent need for governance that addresses the needs of the people. The electorate is increasingly cynical, yet hopeful that the right coalition of political forces will emerge to bring about meaningful change.

Also Speaking on this issue, a Public Affairs Commentator, Abubakar Musa disclosed that, "in Nigeria's ever-evolving political landscape, the question of who holds the power has become more fluid than ever before. As the country navigates a complex web of shifting alliances, defections, and recalibrations, it is clear that political power in Nigeria is no longer concentrated in the hands of a single party or a few power brokers. Instead, it is a dynamic and fragmented force, where allegiances are constantly being tested, and the true seat of power is anything but certain."

According to him, "at the heart of the current political shifts is the ruling party, which, despite holding the reins of governance, is increasingly experiencing fractures within its ranks. The discontent that has been brewing over the administration's handling

rity has now manifested in defections from key party members. What we are witnessing is not just a typical case of political opportunism but an indication of a deeper dissatisfaction with the direction the party is headed. These defections, although framed as strategic moves, are a reflection of the growing disillusionment within the ruling party, especially as it becomes clear that the unity that once held it together is rapidly eroding.'

"This internal crisis is significant because it exposes a critical weakness in the current government: the inability to consolidate its support base amid a challenging national landscape. It's not just about public criticism; it's about how political loyalty, once thought to be unshakeable, is now malleable as individual interests take precedence over party loyalty. The ruling party's inability to bridge these internal divides means that the power dynamics within the party are shifting, with factions seeking to assert themselves as the true standardbearers of the administra-

tion's legacy." He said. Continuing, he stated that, "in the other side of the

cracks in the ruling party's structure. However, they too face significant challenges. While the opposition is united in its critique of the ruling party, it remains deeply divided internally, with various factions jockeying for dominance. Efforts to build a formidable coalition have been repeatedly stymied by infighting and disagreements over leadership and policy direction. As much as the opposition sees an opportunity to capitalize on the ruling party's internal turmoil, it must first address its own fragmentation. The question, therefore, is not just whether the opposition can unite against a weakened ruling party, but whether it can offer a cohesive and appealing vision for the future of Nige-

Also, he disclosed that, beyond party politics, regional dynamics are also playing a pivotal role in Nige ria's shifting alliances. In a country as diverse as Nigeria, regional interests often influence national politics in ways that cannot be ignored. We are seeing southern leaders rallying around the need for greater regional autonomy and economic opportunity, while northern political heavyweights continue to exercise their historical influence

over key sectors of power. These regional interests complicate the already fractured political atmosphere, as leaders strive to ensure their regions are not left out of the decision-making pro-

"The growing emphasis on regional power underscores the need for a more inclusive political process that reflects the diverse aspirations of Nigeria's many ethnic and cultural groups. Without this inclusivity, the shifting alliances and power struggles we are witnessing may deepen existing divides, making national cohesion more difficult to achieve." He added.

For the Nigerian electorate, these shifting alliances are both confusing and frustrating. Many Nigerians are left questioning whether their leaders are genuinely concerned with the welfare of the people, or simply engaged in a game of political maneuvering. The increasing sense of disillusionment among the populace cannot be ignored. Voters are weary of a political class that seems more interested in maintaining power than addressing the pressing issues of the day-economic hardship, unemployment, and security challenges.

"I will therefore urge the Commissioners for Information to take advantage of this very important Institute once it takes off, in order to further build the capacity of our staff in combating the menace of fake news, misinformation, and disinformation," he said.

UK, Conservative Party, Kemi Badenoch, has replied to Nigeria's Vice President, Kashim Shettima, saying she stands by her remarks about Nigeria despite criticism that she is denigrating the country.

Badenoch has allegedly described her upbringing in Nigeria as being overshadowed by fear and insecurity in a country plagued by corruption.

Born in the UK in 1980 to Nigerian Yoruba parents, banker, Hamish Badenoch, and took her husband's sur-

Before she was elected leader of the Conservative Party, Badenoch described Nigeria as a socialist nation brimming with thieving politicians and insecurity.

"This is my country. I don't want it to become like the place I ran away from. I grew up in Nigeria, and I saw firsthand what happens when politicians are in it for themselves, when they use public money as their private piggy banks, when they pollute the whole political

"I saw what socialism is for millions. I saw poverty and broken dreams. I came to Britain to make my way in a country where hard work and honest endeavour can take you anywhere.

According to the communiqué, the total gross revenue available for November was N3.143 trillion, with deductions amounting to N103.307 billion for collection costs and N1.312 trillion allocated to transfers, interventions, and refunds.

resents an increase of N490.339 billion compared to the N1.336 trillion recorded in October. On the other hand, gross VAT revenue totaled N628.972 billion, showing a decrease of N39.318 billion from the N668.291 billion reported in October.

From the total distributable revenue, the allocations are as follows: the Federal Government received N581.856 billion, state governments received government councils (LGCs) received N402.553 billion. Derivation revenue, which represents 13% of mineral revenue, totaled N193.291 billion and was shared among the benefiting states.

From the N455.354 billion statutory revenue, the Federal Government received N175.690 billion, state governments received N89.113 billion, and local government councils (LGCs) received N68.702 billion. Derivation revenue,

N121.849 billion and was shared among the benefiting states.

From the N585.700 billion VAT revenue, the Federal Government received N87.855 billion, state governments received N292.850 billion, and local government councils (LGCs) received N204.995

On Friday, CBN issued a circular signed by Mohammed Olayemi, acting director of the Currency Operations Department, reiterating its commitment to addressing the commodification of the naira. The circular referred to an earlier directive from November will carry out increased and 13, 2023, aimed at combating these illicit practices.

Financial institutions found to have violated the rule by facilitating or aiding the release of mint naira notes will face an initial penalty of? 150 million for each erring branch.

Repeated violations will result in stricter sanctions under the Banks and Other Financial Institutions Act (BOFIA) 2020.

To enforce this, the CBN periodic spot checks at bank branches and ATMs and will deploy undercover "mystery shoppers" to moni-tor and identify hotspots for cash hawking.

The circular stated: "The CBN has noted with dismay the prevalence of illicit flows of mint banknotes to hawkers and unscrupulous agents, which commodify Naira banknotes and

The bank also directed DMBs to improve their internal controls, procedures, and systems—particularly at their Cash Management Centres, branches, and teller operations—to prevent their channels from being exploited for illegal transactions.

CBN Says Old N1,000, N500, N200 Notes Still Valid

Nigeria (CBN) has addressed recent misinformation about the validity of the old N1000, N500, and N200 banknotes still in circulation.



Imo lowest record in VAT evidence of dying economy – PDP

ne Peoples Demo-cratic Party, (PDP), Imo State Chapter, has alleged that the recently released data on Value Added Tax, VAT, as generated across the 36 States of the Federation and the Federal Capital Territory, remains a vindication of its previous stand on the dwindling fortunes of Imo economy under Governor Hope Uzodinma's watch.

Imo PDP in a press release signed by its state publicity secretary, Lancelot Obiaku, and made available to newsmen, alleged that the Governor's leadership style had made the state "unattractive to investors.

The party wondered how the State allegedly generated the lowest VAT revenue in the whole Federation of Nigeria, adding that even the second worst performing State, Zamfara, generated N432.80 million compared to Imo's N235.41 million, an amount the PDP described as not only the lowest in the whole country but also "paltry."

"To illustrate the dire state of Imo's economy, the State generated the lowest VAT revenue in the entire Federation, with a paltry N235.41 million.

"This amount is almost half of what the second worst-performing State, Zamfara, generated (N432.80 million).

"Before they blame it on insecurity...it is worth noting that the second-worstperforming State in the Southeast (Abia) generated three times more, while Ebonyi performed nearly ten times better, and Anambra recorded twenty times Imo's VAT figure," he

The publicity secretary of the party revealed that Imo's VAT contribution was a mere 0.2 percent of what Lagos generated, which represents an embarrassing disparity, pointing out that in its analysis of the nexus between the VAT figures and performance of States' economies, the State recorded what he described as very poor performance.

"To be clear, VAT, a consumption tax levied on goods and services at each stage of production or distribution, is paid by consumers but collected by businesses and remitted to the government through the Federal Inland Revenue Service (FIRS).

"VAT ratio, therefore, is directly proportional to the productivity level and health of an economy.

"We are not in doubt that Imo's dismal performance reflects the comatose state of its business environment and overall economy. Nothing can better mirror the state's zero productivity," the party declared.

He disclosed that each wheat farmer received two bags of NPK fertilisers, one bag of 50kg Urea, and a bag of 50kg wheat seeds to enable them to cultivate wheat during the dry season farming.

According to him, with the subsidy, each farmer is required to pay 50 per cent of the cost of fertiliser and 25 per cent of the cost of wheat

He stated that the farmers were selected from four local government areas of the state, namely, Nafada, Kaltungo, Yamaltu Deba, and Dukku, respectively.

"The Federal Government is supporting about 8,000 farmers in Gombe to boost wheat cultivation during the dry season.

"The input subsidy is 50 per cent for fertilisers and 75 per cent subsidy for wheat seeds. Some farmers have started receiving their inputs while others are in the process of receiving them.

"But within the next 10 days, all farmers are expected to have received their inputs to commence cultivation," he said.

Bomoi said that the Federal Government's gesture followed the cost-intensive nature of wheat farming.

He said the government also assigned aggregators to each cluster of wheat farmers to prevent market glut and ensure judicious use of inputs.

ACF Reacts On Tax Reform Bills: Urges FG To Allow Opposition Voice

... Says no democracy without dissenting Views

orthern leaders, under the auspices of the Arewa Consultative Forum (ACF) have urged the Federal Government to be tolerant dissenting voices against the tax reform bills before the National Assembly, saying that fighting them is against the spirit of democracy.

According to the Forum, the policy which is controversial at the moment, and over the past two weeks in the country has been on the Executive Bills sent to the National Assembly, proposing sweeping changes in Nigeria's tax laws.

The National Publicity Secretary, Professor Tukur Muhammed-Baba in a statement on Thursday, said "ACF accepts that periodic public policy reforms are in line with the political and public administrative processes, in which regards reforms are indeed necessary and desirable.

He explained that "nothing in the life of any community is static and policies must try to address emerging challenges, take advantage of new opportunities,

"Debates have continued to rage on the pros and cons of the proposed bills, with positions being argued vehemently and stridently with passion. However, it is concerning that the emerging debates have become acrimonious, pitting sections of the country against each other.

"It is highly regretful that opinions have tended to involve unsavoury and often abusive words meant to denigrate, blackmail or intimidate anyone perceived, rightly or wrongly, as serve the interests of the standing in support or opposing the bills or their specific aspects therefrom as are now under consideration in the Senate", he said.

He lamented that, "the apparent impatience by supporters of the bills, obviously including and espe-cially the Federal Government, to have them speedily processed through Senate, creates and sustains impressions of specific but unstated underlying inter-

He said: "It is therefore a welcome development that the Senate has wisely decided to tarry by electing for wider consultations with relevant stakeholders intended to address areas of concerns.

He stressed that "ACF encourages all concerned to cooperate with the relevant Senate Committee tasked with the assignment, while urging every interest group to see the debates for or against any provisions in the bills as essential inputs into the policy process.'

He Pointed out that the federal government should allow the voices of opposition to the proposed tax bills by aggrieved Nigerians, Muhammed-Baba, adding, "expressions of contrary opinions and views are necessary ingredients of the legislative process, in line with the dictates of democracy, to ensure that the emergence of robust laws that will stand the test of time.

"Ultimately, the outcome of such laws emanating from the process will whole country and not, as some insinuate, specific sections or interests to the detriment of others. It is in line with the above that ACF constituted a committee of experts to study the proposed bills so as to come out with appropriate recommendations to be forwarded to appropriate organs of government", he further stressed.

"In the meantime, ACF urges restrain, decorum and mutual respect in any discussions of provisions in the proposed bills as, in accordance with the timeless adage, no one has monopoly of knowledge and/or wisdom", he added.

Queen is not one to pretend over issues. In this exciting interview, Blessing opens up on many things concerning her life, career and marriage. Enjoy this no holds bare interview with ORJI CHUKA

Ingratulation on your reelection as AMP President, tell us what it has been like since you took over as AMP President; your achievements so far, welfare plansformembers?

I have been a member of Association of Movie Producers, (AMP), Nigeria, for over 16 years now. I was the National Treasurer of the Association from 2018 – 2020 under the leadership of the former President Emeritus Ralph Nwadike. In 2020, I became the National Vice President of the Association under the leadership of Peace Anyim Osigwe till 2023 when we lost her.

I was later sworn in as National President on March 17th, 2023; and re-elected for another term this year. It has been an amazing journey but with a lot of work because I hardly have time for myself these days. In July, I was in London for the Nigerian Week hosted by SRTV London, where I received recognition for the Most Devoted Industry Leader, 2023. I must say I deserve it because I have worked very hard. In August 30th, 2023, Actors Guild of Nigeria, AGN, honored me for my remarkable leadership in the guild and the creative space. In September 17th to 24th, 2023, I was in Toronto, Canada, for the Toronto International Film Festival, where I spoke at the event and also received the Achievement Awardin Media and Creative industry.

I am happy because I have not disappointed my predecessor and other past presidents, knowing also that I can count on their advice and support and that of all the members at all times. I am not ashamed to ask for help from them, even my members when needed because nobody knows it all. As I try to complete most of the projects the past presidents began, I am also charting a new part for the Association.

With new leadership, no matter how you look at it, it comes with new perception on how things should be done and how we see and look at things. In all, it has been an amazing journey, I have the support of my members because they are happy with my leadership and I'll continue to do my best to make sure it stays that way. It will always be AMP first and AMP always.

You started as a dancer and model more than 20 years ago. What is the difference between actors that started in your time and actors of today, especially the young ladies; in terms of character, discipline and approach to work?

No. I started as an actress, and a model, later added dancing along the line. I started dancing in musical videos and I danced for the likes of Tony Tetuila, Eedris Abudulkareem, Pasuma Wonder, Adex and Asker among others. I also started modeling when jobs were not coming, for me; it was necessity that drove me into all these ones, otherwise the passion was acting.

I had so many bills to pay and I was raised in a manner that as a woman, you shouldn't depend on a man, so the man factor providing for me was not really my thing. In fact, I came into Nollywood as an 18-year old virgin till I was 21 years; my mom did not raise me to depend on any man. So, if there is no acting job, dancing job will be available and when there's no dancing job, modeling job will come. Jobs to put food on the table and when they come, I am very professional and disciplined about it.

I did the TV series Super Story and This



Life multiple times for Chief Wale Adenuga, One Bad Apple, Only God forgives, and Officers Wife etc. One thing people I have worked with either in acting or other businesses know about me is that when you give me your call time; your call time is your full time. If I don't have time, I won't take your job and one thing I never do is take a job when I'm still on another job. I must finish the production, go to my house, sleep at least two days, and eat the food I cooked because I am a very good cook; before I will take up another job.

I consider my health in everything l do that is why l am careful with what l eat outside because l don't know what they used to cook their food, so it's always important to come back home, detox, make your food, sleep and rest before you take up another job. Most of the actors today are not disciplined. As a producer, l am a much disciplined person and harsh when l need to be. Almost everybody l worked with have not come to set late because of the kind of person l am. I will make sure l put you in a hotel a day before the production starts.

On the other hand, if you don't come a day before the production and you want to come same day, you must come at call time or you will have to talk to my lawyer. I don't want to know what happened because it's my money that is wasting. So, when it comes to me, I'm very strict and people that work withme know that.

Yes, a lot of actors are not disciplined like in our days and the ones before us. When you tell them call time is 8:00am, you will see some of them coming by 4:00pm and some of them especially ladies take three hours to make up. I don't think most of these ladies depend on money they make from acting to survive, they either have other busi-

nesses orthey have men that are bankrolling them. So, if you don't have a man that is bankrolling you, neither do you have other businesses that generate money for you, then you would appreciate and respect time. Yes, after I had my son; I stopped danc-

Yes, after I had my son; I stopped dancing and also stopped runway modeling, I only do photo modeling now. Of course, I added movie production 14 years ago into my portfolio. I'm a serial entrepreneur: I sell charcoal, I sell clothes and I do aso ebi for parties, I do a lot of things just to make sure that I don't lack, to keep up with my bills because it's a lot to stay in this industry.

About your foundation, tell us more about the lives you have touched especially that of the widows and why you are particular about the widows?

The foundation has been on for many years; in 2018, we celebrated our 10th anniversary. By next year, this foundation would be 17 years. Every 14th of February, we celebrate 1000 (one thousand) widows and aged women, on Val's day which is always February 14th.Last year, it was held at the palace of the Emir of Zauzzau in Zaria, Kaduna State, As you know, we choose a state that we will go each year. The only year we don't do it is during election year because of the uncertainty in the country. Again, I don't want anyone to compel us to politicize the foundation, because it's strictly a calling from God. It has nothing to do with politics or religion.

We go through the traditional rulers to help us select genuine widows who are truly in need. We organize parties where we provide music, food and drinks. Some of the side attractions include dancing competition; we also do balloting for sewing and grinding machines and also give them sti-

pends to start a trade. When you help a widow, you are helping the children also because she's not going to allow them suffer. 80% of the funding for now is from me and this depends on how buoyant I am at that time. Organizing the program alone, the DJ, food, drinks, for the guests including the 1,000 widows and aged women that come because you have to cook for more than this number as some will also come with their children. We also we give them six yards of ankara each and the wrappers alone cost about 6,000 naira, we are talking about the cheapest and good wrapper that will at least last for some time. We are talking about millions of naira.

Last years program, I spent over 7million naira and you know a dollar was about 360 naira, with dollar now at over 1,000 naira and fuel at close to 1000 naira; I will need over 10,000,000 naira to host the program next year which is just a few months away. No matter how small l try to do it, it will still cost a lot. In 2018, when we hosted the wives and mothers of our fallen heroes, at the Army Cantonment, Maryland, Ikeja, Lagos state, 3 days before the program, we brought some facilitators to teach them how to make shoes, bags etc. At the event, we did balloting for sewing machines and most of them won. We also gave some of them token for start up. Some told us they want to sell food, some pure water, some fairly used clothes and akara, etc. Anything that N20, 000-N50, 000 can start up, we do that yearly when we host the program.

I asked God what do l do. He specifically said l should not do it in one state so that l don't recycle widows. I've done it twice in Edo State because I'm from there and also twice in Lagos state because I live and work here. I've also done in Niger state, Ibadan Oyo state, Ile ife- Osun state and Kaduna State. I did not just start it; it was God that instructed me to do it.

Each time the event is getting closer, I become restless because 80% of the funding comes from me. The remaining 20 % come from outside support. I used to fund it alone but two years ago, my cousin Prof Azeez Butali based in the U.S through his foundation paid for 6 yards of wrappers for 100 widows and promised to make it a yearly thing. Mr. Jimi Agbaje, my mentor and godfather; who is also a Patron of the Foundation paid for 6 yards of wrappers for 100 widows and give a token to five widows business as a start up, a support he promised to continue on a yearly basis. Prof Pat Utomi also a patron supports the foundation and my uncle and great friend, Apostle Johnson Suleiman also supports the foundation whenever we reach out to him

My online fans and well wishes support us too and that explains the 20% support I talked about. I pray that more people will come on board because I can't continue to put in 80% of the funds yearly, so that I don't go bankrupt. I have faith that one day, it will be only 50 per cent and it will continue to go down. I am one person that never gives up on the things that I believe in. I know that we're always going to continue to do it because it brings a lot of joy and smile to the faces of these widows and their children and anything that brings peace of mind to humanity is what I live for.



n a country where many young Nigerians have resulted to fleeing the country for greener pastures, Femi Ögunsanwo's 'Omera' tells a reverse 'japa' story, where the lead (Desmond Bryce) is scammed of his travel funds and subsequently presented with an opportunity by his uncle, Abara (Akin Lewis), to head his NGO, the Ajogu Empow-erment Foundation (AEF). Unknown to Omera, he is heading to a community where its people are its own enemies. How much can one do in a land whose people are blinded by personal gains?

Madam Regina (Mary Kowo) and the Chief Priest of Ajogu, Atamebo (Williams Omo Godwin), the catalysts of Ajogu's misfortunes, in order to further their personal ambitions for wealth, serve as a tool for Idu—a neighboring village currently at war with Ajogu over land mass—to secretly acquire parcels of Ajogu land. As the story progresses, this duo orchestrates chaos and encourages natives to sell their lands under the guise of helping them immigrate to the big city.

Exploring theme of greed and corruption, Africa Magic's Omera weaves a web of personal ambition, community struggles, and complex relationships. With every episode, we are taken on a journey filled with Ajogu and soon to be Onu



power struggles and betrayal, but one sub-theme that adds to the overall depth of the story is forbidden love.

The problem? Iyoma is a single mother who is not from a noble family and Ameh is the Crown Prince of

(king). One challenge the couple face is that for Ameh to become king, he has to marry a noble woman, and according to Ajogu, Iyoma is far from noble. Unknown to the whole of Ajogu, Ameh plays a key role in Iyoma's current standing in society.

Ajifa (Mofe Okorodudu) and Akoji (Kingsley Nwachukwu) are also faced with the same dilemma, with Ajifa being a daughter to high Chief Alewo and Akoji being the head of the Ajogu Vigilante. Their union is under threat, and for the most part, they are the only compatible duo in the series. This side of the drama adds emotional stakes to the overall story.

Moses Simon's Stunning Strike Saved Antoine Kombouaré's Job With Former Porto Man Linked To Nantes

oses Simon's spectacular strike against Stade Rennais may have saved FC Nantes manager Antoine Kombouaré's job, as the Nigerian winger secured a vital 1-0 victory in Ligue 1, Soccernet.ng reports.

Simon's unstoppable effort, leaving veteran goalkeeper Steve Mandanda helpless, handed Nantes their first win since August and lifted the team out of the relegation zone into 13th place with 14 points.

Stade Rennais believed they had equalised from a corner shortly after Simon's goal, but VAR intervened, ruling the effort out and keeping Nantes ahead.

The result was a breath of fresh air for Kombouaré, who had been under immense pressure following a string of poor performances

Before the Rennais victory, Nantes had gone 10 matches without a win, drawing four and losing six.

Speculation was rife that former FC

Porto boss Sérgio Conceição was being lined up to replace Kombouaré, with reports suggesting a draw or loss would seal his fate. However, Simon's moment of brilliance seems to have postponed such plans.

When asked if he knew his goal had saved his manager's job, Simon, who is Nantes' top scorer in Ligue 1 with four goals, brushed it off:

"Who said the coach was in danger? We don't know. We won for ourselves, for the coach, our supporters, and the people of Nantes."

Since being reappointed in March 2024, Kombouaré has struggled to replicate his success during his first spell, which included a Coupe de France triumph in 2022.

The manager will hope this victory signals a turning point, as Nantes prepare for a crucial away clash against Brest this weekend.





Boniface Edges Closer To Long-Term Contract Extension At Bayer Leverkusen

Super Eagles star Victor Boniface is close to signing a contract extension at Bundesliga champions Bayer Leverkusen, Soccernet.ngreports.

Boniface has been impressive for Bayer Leverkusen since his €21.7 million transfer from Royale Union SG last year. Super Eagles striker Victor Osimhen has advised compatriot Gift Orban to leave Lyon and join him at Turkish Super Lig club Galatasaray, Soccernet.ng reports.

Orban has struggled badly at Lyon since his transfer from Gent in January. The Nigeran striker has registered just five goals in 21 appearances. This season, he has even missed out on the match day squad on different occasions.

Due to his struggles, there have been talks that the 22-year-old will leave Lyon for another club in order to get more game time. The talks have been further fueled by the fact that Les Gones have to sell some players to balance their books and avoid

financial fair-play breaches.

German sides like Leipzig and Borussia Dortmund have been linked with Orban, but they have to see off interest from Turkish side Trabzonspor.
