

Unity or Division? The Politics of Our Time

n a nation as diverse as Nigeria, the concept of unity is both a necessity and a challenge. We must also reject political rhetoric that divides us and instead focus on building bridges across our differences."

"The politics of division has only led us to a cycle of stagnation. It is time to chart a new course-a politics of unity that reflects the strength of our diversity and the shared aspirations of every Nigerian. This is not just an ideal but a necessity for the survival and prosperity of our nation." He added.

The question remains: will Nigeria rise above its divisions to forge a united future, or will the politics of our time continue to pull us apart? The answer lies in the hands of every Nigerian, as the nation collectively charts its course forward.





Court Grants Canadian Financier Right To Repossess Arik Air Aircraft Under Cape Town Convention

The ruling, issued on November 27, 2024, by Justice Alexander Oluseyi Owoeye, follows the issuance of Nigeria's Federal High Court (Cape Town Convention and Aircraft Protocol) Practice Direction on September 12, 2024.

This new practice direction estab-lishes legally binding rules that rein-force Nigeria's commitment to the Cape Town Convention, instructing courts to apply its provisions in relevant cases without interference from other legal provisions. The court granted EDC the right to reclaim and dismantle the CRJ1000 aircraft, which had been grounded by Arik Air. The disclosure, first reported by chaviation on Thursday, was shared the same day by Minister of Aviation and Aerospace Development, Festus Keyamo, on his official X page, endorsing the news and affirming its authenticity. "First victory in court in Nigeria courtesy of the Cape Town Convention. The courts applied the CTC to the fullest and allowed instant repossession of an aircraft," Keyamo's tweet read. This ruling marks a pivotal moment for Nigeria's aviation sector, highlighting the country's growing commitment

to international leasing standards, particularly those of the Cape Town Convention.

The applicants in the case were Captain Samuel Caulcrick, the local repossession agent appointed by part-out firm Merchant Express Cargo, and Captain Isiaka Oyeshina Akinfenwa, CEO of the firm. Merchant Express Cargo had the CRJ teardown contract.

In previous hearings, both men had criticized the tactics of the Economic and Financial Crimes Commission (EFCC) and Arik shareholder and founder, Johnson Arumemi-Ikhide.

Among other findings, Justice Owoeye's ruling revealed that EFCC officials had harassed, threatened,



questioned, intimidated, detained, and threatened to detain the applicants during their attempts to repossess the aircraft.

The court granted EDC the right to repossess and dismantle the aircraft and issued an order preventing EFCC officials from interfering with the process.

The CRJ1000 remains in storage at Lagos airport.

The aircraft, a 2013-built regional jet, was leased to Arik Air in 2014 by JEM Leasing Limited, with EDC helping finance the aircraft's acquisition and holding a mortgage over it.

In December 2022, JEM Leasing moved to deregister and repossess the aircraft after Arik Air defaulted. At the same time, JEM entered into an agreement with Alberta Aviation Capital Corporation to sell the CRJ1000, with EDC retaining the mortgage.

Arik Air had stopped operating the aircraft in 2019.

Arik Air, which had grounded the CRJ1000 in 2019, had been struggling financially, leading to its receivership under Nigeria's Asset Management Corporation (AMCON) in 2017.

The aircraft had been deregistered in 2022, but efforts to repossess it were blocked by the EFCC, citing concerns about the legality of the sale.

The Federal High Court's ruling clears the way for EDC to proceed with the repossession, marking a significant step forward in the enforcement of international aviation laws in Nigeria.

025 Budget: FG Allocates ? 17.3 Billion For Group Life Assurance Cover For MDAs, Corpers, and Others

ne Federal Government of Nigeria has allocated a substantial sum of N17,313,619,734 in the 2025 budget for the provision of Group Life Assurance coverage for employees of Ministries, Departments, and Agencies (MDAs), as well as members of the National Youth Service Corps (NYSC).

This allocation includes

funds for both the insurance

coverage itself and the administrative and monitoring costs to ensure effective implementation of the policy

Group Life Assurance is a mandatory policy in Nigeria under the Pension Reform Act of 2014. The policy mandates employers in both the public and private sectors to provide a death benefit of at least three times an employee's annual salary in the event of their untimely demise.

The government's alloca-

tion of N17.3 billion highlights its commitment to the welfare of its workforce, offering a financial cushion for the families of deceased employees. This coverage will extend across all MDAs, including critical security agencies like the Department of State Services (DSS), as well as other public institutions. Furthermore, the policy will also cover NYSC members, reflecting the government's recognition of their contributions to national development.

In 2022, the OHCSF resolved 648 backlogged death benefits to the families of deceased officers.

CBN Attributes Exit of 1,000 Staff To Digitisation, Operational Restructuring

he Central Bank of Nigeria (CBN) has confirmed that 1,000 staff members voluntarily resigned as part of its ongoing restructuring process, which is being driven by the adoption of digital technologies. This move is aimed at streamlining operations and addressing redundancies caused by the shift to a more technology-driven banking model.

Bala Bello, a deputy director representing the CBN Governor, Yemi Cardoso, made this announcement during an appearance before a House of Representatives ad hoc committee investigating the matter. The committee was formed following concerns over the large number of resignations and the? 50 billion compensation payout to the departing employees.

"You are very much aware, chairman, that the entire world is going through a process of digitising its operations. When that happens, a lot of opportunities are created, just as redundancies are equally created," Bello explained.

The CBN's restructuring efforts are also influenced by the lack of vacancies at the managerial level, which has

Interestingly, some of the departing staff members have expressed plans to start their own banks, with the CBN offering its support.

"A lot of opportunities are out there. Among the people who have left, there are three or four who are going to set up a bank. We have assured them that if they need the sup port of the Central Bank, we will provide it," Bello revealed.

IMF Warns \$1 Trillion In Undisclosed Debt Threatens Economic Stability Of Low-Income Nations

heInternationalMonetary Fund (IMF) has raised an alarm about the growing risk posed by undisclosed public debt, which is estimated to total \$1 trillion globally. This hidden debt is particularly concerning for low-income nations, which are already facing significant fiscal challenges.

In a blog post shared on

its official X account on Thursday, the IMF high-lighted that undisclosed government debt undermines accountability and increases the risk of corruption. The IMF explained that "hidden debt" refers to borrowing that a government is liable for but does not openly disclose to its citizens or creditors. While this debt is often

kept off the official balance sheet, it remains a real and growing concern.

The IMF noted that, while global public debt exceeds \$91 trillion, undis-closed liabilities, though smaller in comparison, have a disproportionate impact on developing economies. These countries are already struggling with rising debt

and escalating refinancing

needs, compounded by higher interest rates.

The IMF emphasized that low-income nations, in particular, are vulnerable, with their annual refinancing needs having tripled in recent years. The situation is worsened by slow economic growth and the ongoing high-interest-rate environ-

ment.

The IMF stressed the risks posed by a lack of transparency in borrowing, noting that without clear information about the extent of debt, corruption becomes more likely, and the potential for fiscal crises increases. The IMF's latest research, titled "The Legal Foundations of Public Debt Transparency:

Aligning the Law with Good Practices," examined the legal frameworks of 60 countries, revealing vulnerabilities that facilitate hidden debt. These include narrow definitions of public debt, insufficient disclosure requirements, confidentiality clauses in contracts, and weak oversight mechanisms.



'Assassination Attempt': Kaduna APC Denies Complicity, Says Senator Not Cooperating With Police

Mother Arrested In FCT For Abandoning Newborn Over Financial Hardship

he Federal Capital Territory Police Command has arrested a woman, Khadija Ali, for allegedly abandoning her newborn baby.

Ali was reported to have dumped the baby along a bush path near Crush Rock, behind the uncompleted Red Bricks Market in Mpape, Abuja.

A statement released on Sunday by the Command's Public Relations Officer, SP Josephine Adeh, revealed that the baby, believed to be just a day old, was discovered at about 10am on January 3, 2025 after police operatives from the Mpape Division's Juvenile and Women Care Section responded to a distress call.

Adeh stated that the infant, wrapped in a cloth, was rescued and taken to the Mpape Primary Health Care Centre for medical evaluation.

She added that, following an examination, medical personnel confirmed the child was in stable condition.

The statement partly read, "On 3 January 2025, at about 10:00 a.m., police oper-atives from Mpape Division's Juvenile and Women Care Section responded to a dis-tress call and found the baby wrapped in a cloth. The child was promptly rescued and the conclusion of investiga-

taken to Mpape Primary Health Care Centre, where medical evaluation confirmed the baby is in stable condition.

Adeh disclosed that acting on a tip-off from concerned residents, police apprehended Khadija Ali, who confessed to abandoningherbaby.

"Following a tip-off from the community, the baby's mother, Khadija Ali, was arrested. During interrogation, she confessed to abandoning the baby, citing her inability to care for the child following her husband's abandonment," Adehsaid.

Condemning the incident, Adeh described it as a grave violation of the rights of the child.

She added that Ali would be charged to court for allegedlyviolating Sections 14 and 16 of the Child Rights Act, 2003.

"The FCT Police Command vehemently con-demns this act of child abandonment and reassures the public of its commitment to protecting the most vulnerable members of society.

Kaduna: Dead Body Of 33-Yrs-Old Found Near Baptist Seminary School - Family Source

33-yrs-old boy, Amos Jatau, report-Ledly killed by elements suspected to be bandits or assassins in Kaduna state, has been found.

The lifeless body of the deceased was found on the way to Baptist theological Seminary School located along Yakowa way on 31st December 2024.

A Cousin of Amos Jatau, Gbagyi by tribe, who spoke to our reporter Friday, at the family house, at Nassarwa road, U/Boro old Market area of Sabon Tasha, chikun LGA of the state, said the late was going for prayer when the sad incident occurred.

He further explained that Amos body found was kept in seminary school premises, with his bed pillow, Bible and some of his clothes before he was reportedly taken to mortu-

view, Amos Jatau family member said "We receive call in the evening of 31 December 2024 to come to the mortuary at U/Boro to confirm the dead body found at the Baptist theolog-ical seminary. When we went there, we confirmed it was Amos Jatau.

He was buried on Friday, 2nd January 2025. We gathered that his body was found at the place of prayer at the seminary. We're yet to know whether he was killed in the area or killed and brought to the place and dump.

"His properties found around him include his pillow he went with, to the prayer place, his Bible and some of his clothes. From police report and those who took him to police, said some sticks were found around his dead body, indicating he was beaten to death.

"The seminary conveyed In a clarification inter- the body to the mortuary and report to the police. He went there alone to pray. Is an open place. Individuals and group use to go for prayers there.

> "There are some bushes around the seminary area located off Yakowa road, behind a Jaruwa community, Chikun LGA of Kaduna state. He sometimes go there to pray. He leave in a place not too far from the Baptist seminary.

> "He went for his marriage introduction on 20th of December 2024 in preparation for his marriage. Family house located in Nasarawa street u/boro old market.

> 'Police were unhappy and promised to tight up security in the area of the seminary when it was reported to them, including the seminary people too.

Neighborhood and friends attested to the fact that Amos Jatau was a com-

plete gentle person and does not hot fly.

"Amos is a complete gentle person and does not hot fly. Is a builder and keep to his promises, his friends in church testifies his gentility", the family said.

On whether Amos Jatau had issue with anyone previously or could it be bandits? the cousin explained "We're not aware of him hav ing any issue with anyone or group, but as human, someone could have issue with him.

Kaduna state has insecurity problem and it may not be far from bandits because I saw a post someone did that a community was invaded in southern Kaduna, Ekwa church was burnt.

"So it could be, but we're yet to have any information to that regard. No body injury sustained except little swollen face and not part of the body missing to suspect ritual.

El-Rufai Storms Prison, Meet His Ex-Chief Of Staff In Remand On Alleged Money Laundering

ormer Governor of Kaduna State, Mallam Nasir El-Rufai, Thursday reportedly stormed Kaduna prison and met his former Chief of Staff, Mohammed Bashir Sa'idu, been remanded at the Correctional Service Facility on charges relating to alleged money laundering.

The immediate past Kaduna Governor however refused to speak with newsmen on his mission after the visit.

Reports had it that, the visit by Mal. El-Rufa'i came just hours after Sa'idu, who was also a former Commissioner of Finance and Local Government in Kaduna state, during his tenure was remanded in a Correctional Facility over allegations of corruption and money laundering while in office.

The former Governor reportedly sought audience with the embattled Saidu who was arrested on Monday and taken to a Magistrates' Court at Rigasa, which ordered that he be remanded inprisoncustody.

Reports also said Mallam el-Rufai, accompanied by three key figures and former Commissioners during his tenure, arrived at the facility around 10:19 am and left about 30 minutes later around 10:47 am.

The former, in the brief visit was accompanied by the former Commissioner of Education, Jafaru Sani; former Commissioner of Human Services and Social Development, Hafsat Baba; and former Commissioner for Environment, Ibrahim Hussaini.

However, Nasir El-Rufai, donning a green cap and light green Agbada, subtly rebuffed attempts by journalists to have a word with him on his visit to the Correctional Centre.

Other allegations include the sale of \$45 million in State-owned foreign currency at an undervalued exchange rate of N410 per dollar, instead of the parallel market rate of N498 per dollar, causing a loss of over N3.96 billion to the government.

Furthermore, the insiders hinted that this transaction breaches Section 18 of the Money Laundering (Prevention and Prohibition) Act, 2022

Additionally, the former aide is accused of failing to account for proceeds from the sale of government houses in Marafa Estate, Kaduna, amounting to approximately N244 million. This constitutes a breach of trust under Section 300 of the Penal Code of Kaduna State. 2017.

Orits Wiliki known as Koleman Revolutionarie is one of the legends of the Nigerian music industry. A former vice president of PMAN, he is currently the Chairman of the Music Copyright Society of Nigeria, MCSN, a collecting society for creative artiste. Samuel Orji chatted him up on issues concerning the music industry in this exclusive interview.

A fter close 41 years in the industry you are not slowing down, you came out with two albums at the same time after 10 years. Why?

I am endowered with many songs in my head and if I dont pull out as many as I can, I will be doing a lot of injustice to myself. When I decided to do double album in my 30 years anniversary, there came a change and I decided to switch to full reggae gospel music. Was I not playing gospel before? Yes, I was, but I realized that after 30 years; it will be nice to concentrate all my efforts in glorifying God because he is the one that gave me the gift and made me all that I am.

You switched to gospel because ou became born again or because the market was shifting to other genreofmusic? No. I have always been born again; moreover, the market is not shifting. I think it was Gods time to open my eyes to him. If I cannot do that in my life time, then I am doomed because he is the giver of the talent, the voice and the inspiration. Since that switch there is no going back. There was a time reggae artistes came together in Badagry to seek for a way to resuscitate reggae, how far have you people gone in achieving this? Few of us came together and acknowledged that the spotlight is not on the traditional root reggae because reggae has evolved to dance hall and others. So, the hard core traditional reggae music as people know is no longer popular on our radio stations because they no longer play it, as a

result; you cant be popular as you used to be. You see that's where we lost it as a society because when a genre like reggae dominated the airwaves, there was less of cultism and drug abuse.

Talking of drugs, you know that reggae artistes are associated with harddrugslikemarijuana?

No! We dont do drugs, not just me alone because this is a misconception. By the time we started coming out, I was doing braids and I saw the discrimination by the society against the people wearing braids. When they see you with dreadlocks they consider you as dirty. Our people on the other hand, did not did not help matters because they were actually dirty looking, so people also assumed that once you wear dreadlocks, you must smoke hemp; but that's not correct. Those of us that were popular that time, I, Peteside Ottong, Mandators and Ras Kimono, including Andy Showman and Isaac Black, none of us smoked There was content that was inspiring, there was something to listen to and the youths that were listening followed suit and were able to change the narrative. There was no cultism or drug addicts like you are witnessing now. We were forced to do a particular program with the creative industry group, CLJ.

Nigeria is lost. Look at what our youths are doing even in secondary schools and you are talking about leaders of tomorrow, what leaders? Its what they listen to that gingers them. They play these unhealthy contents on air that talk about buddy, dollars, drugs, drinking and smoking, etc, definitely thats what the youths are listening to. They are playing so much of it on the airwaves as against the good music that has content. Sukus will leave this country again. The way the music came and affected Nigerians that even choirs and churches started creating that kind of music to worship God.

that kind of music to worship God. Nigerians were losing business because all the big hotels that had band playing were employing Congolese and Zairians. We had no business anymore, the airwaves were dominated by this kind of music and it got to a point Charly Boy and I, said, we have to do something. As PMAN excos, we started a campaign and worked underground to ensure that Nigeria songs were played more on air. We visited the NBC on a number of occasions and eventually it was agreed that the play time should be 80/20 instead of 60/40 it was before. That's 80 per cent for Nigerian songs and 20 per cent for foreign. The second reason was that having left the scene for a while, people were getting tired of the songs: give us water, no light, no road, no transportation and others. I think the message became saturated and they wanted to hear a new thing because as much as we shouted; nothing was changing, so what was the point listening to this kind of music. Fela shouted his own until he died, same with Ras Kimono, but how much did this impact on the people? Then another genre of music came up, it came first as hip hop; kudos to Kennis Music and the others who turned the whole thing around. We stated hearing a lot of pop music on our airwaves. It was selling and from there we entered the afro beat and you saw a lot of people that came under that platform that were doing well. Remember, music comes in circles like fashion, if you are think-

What of Majek Fashek?

I am coming to that. Seven of us that were dominantly in the realm at that time were not smoking. We wanted to carve that niche and change the narrative that reggae artistes were hemp smokers and that helped us a lot. When I decided to wear my dreadlocks, I spend money to keep it clean, same with Ras Kimono and Mandators.

We became the bride because with such posture, we were able to discuss and entertain important people. One of the biggest concerts I played was performing before 17 heads of states for the South African liberation. We were able to change the narrative and thats why we went deep in our message. Are you assertive that there is cult-

ism in the music industry? Of course there is and its too strong.

But somebody said this is not true, its just a gang thing. You belong or don't belong to my group? You are in this country and see what is going on in the internet. If you don't belong to those cult groups you can't excel. We cannot continue to deceive ourselves that there is no cultism and there are no drugs. Look at Mohbad's story, can you say all those things he said are lies.


Reggae reigned for a while before other genre of music took over, what led to the gradual phase out of reggae in the Nigerian music scene?

There are three reasons why it happened. At a point, everybody jetted out and the scene became empty. Now a new music evolved which was Sukus, I was then the vice president of PMAN and we never believed

ing that afro beat will be there forever, its a lie. If new sound that people love comes out thats what will hold sway again.

Lets talk about your victory over Premier Music and why you took themtocourt.

Its a battle I believe was deservedly won because all these years artistes could not stand up against their record labels. It was like a master slave relationship. A lot of bad contracts were signed because the artistes were desperate to record and 90 percent of them did not have lawyers to guide them through.

The record companies knew that these artistes were desperate and they wrote the contract in such a way it will favor them (Record Labels). My contract was signed with PolyGram Records not Premier music and it was three years, three albums. Moreover; I was not like an artiste moving about with demos looking for a production company.

Istarted my record in Paris, France, with a company called Alanche' de' Lamour. I had an international manager then, I had to complete the production with Lemmy Jackson after I moved back to Lagos. I and Lemmy Jackson were running a company called Lemmy Jackson Music. I was a producer, himself and Sam Okhua, we were doing a lot of productions. We had people like Alex O. grooming voices because a lot of the artistes we were recording could not sing, so it was a complete studio.

Already, Alex O. was signed on to Poly-Gram Records and we were doing his job. So, we took his job to the MD then to show that we are through, so that he could listen to it. When we got to the MDs office, Lemmy Jackson slot in the cassette for him to listen, incidentally the side he played was my side because I have just finished my work and it was the Ten Commandments that was playing.

Lemmy wanted to stop it, but the MD said no that he likes the song, he asked who was the artistes and Lemmy pointed at me and he said, he was interested in me. The MD listened to about four more tracks before it was now changed over to Alex O songs.

He asked and I told him that my recording company was in France, but we can give them the marketing deal to promote the album in Nigeria. That was the deal. I finished my master tape before I brought it to PolyGram Records. The following album was Conqueror; I sponsored it myself and brought the master tape to them. The third one was, What This, What Dat and by this time, PolyGram Records had gone and PremierMusic had taken over.

In the contract, the copyright gives them the power to explore the copyright for 25 years exclusively. So, you cannot do anything with any company with that music, you dont have any right at all until after 25 years. Beside that how much were we getting? 20-30 kobo per an album and that was in 1989. The entire contract from that period which was tenable was 25 - 30 Kobo because nobody was getting 50 kobo per album. Assuming you sign a contract for 30 kobo per album, its your wish that you explode because 30 kobo multiply by 500,000 copies is a lot of money; however, here is the danger. Assuming they started your job from the scratch, they will tell you that the money they spent to record you, for the production of the master tape, the video, the promotion and any other money they spent on you must be recouped from the 30kobo you are earning. By the time they remove all these, they will tell you that you owe the company about ?5mor?10m. They will now collect ?10m from the 30kobo you earn per album. That's why you see that no artiste was getting royalties. A few artistes like us that were getting royalties were those that were able to sell in high quantity. We were like slaves and the only money that we made by the grace of God was during tours, concerts or endorsements.

After the three albums, I told them I was not going to renew the contract that was when I formed Cowrie Music as my label and every other job from then was released on my label. When PolyGram was in charge, one of the clauses in the contract says they must give me a statement of account every 90 days. Whether they owe or you owe, the record must come to you; to know how much they have sold, how much your royalty ought to be, what should be recouped from what you owe. Thats what PolyGram was doing and they were religious about it.

So, when PolyGram Records left and Premier Music took over, for eight years we never had any statement of account. I called them, what's going on? They said they were over whelmed with the change and everything. They now sent me? 100,000 cheque, for eight years. I asked what the money is for because there is no statement backing it, but they said they were working on it, that they were going to send it later. Six year after, I did not hear from them.

On the 15th year, I wrote to them that I was no longer interested in the contract. They said no, until I finish the 25 years that even if I want to go, let it be clear that I cannot do any other thing with those music until after the 25 years of their exclusivity expires.

I said okay, we still have 10 years to go: but am not interested in this contract again because you have bridged it. You are not respecting the contract and you have not been paying me my royalties. My town man was the Managing Director; I called and told him that I don't want to disappoint him, that's why I am not taking them to court for now. He assured me that things will be sorted out.

They wrote another letter and explained that they were actually overwhelmed. Later, they sent me? 45,000 and I told my account officer to return the money to them because there was no statement backing the money up.

I now told my lawyer to write them officially that this contract is dead. In fact, they now said that after the 25 years they still own the contract for my music for life.

But you have a copy of the contract?

Yes, its clearly in most of the contracts a lot of artistes sign. I told them that I have a little knowledge about how copyright works. There is no copyright thats for life. Copyright is contractual and you have limit of time that you can maintain the exclusivity especially when you did not sponsor the recording. I sponsored all my recordings; you did not sponsor any of them.

After the MD died, I wrote and told them that I really wanted to go; they said no they are ready for any action I want to take. I told them that the contract is even inconsistent. I know that any contract that is inconsistent is null and void. Even if we signed it, you said three years, then 25 years and from that you said life. Thats why I took them took them to court.

To God be the glory, what we asked for was?100m, but the court through their discretion brought it down to?50m. If I knew what I know now, I would have sued them for?500m.

Do you know that they also became my publishing company outside the shores of this country? The contract I signed with you was not worldwide, but you were selling my music world wide. I never signed any contract with you to be my publisher. Your job was to market, promote and distribute my job in Nigeria and then you became my publisher: signing out my jobs to several companies abroad, collecting foreign exchange and you never told me.

A company wrote me and said they were interested in my song, fight the fire. That was the beginning of this case. I said okay, however, they also wrote to Premier Music because it was published by Premier Music, so they wrote them because Premier Music claimed to be the publisher. Premier Music replied the company and the company copied me and said, is that true; I said, its not so. Through the company I was able to get other information I never knew was existing. Everything was what we presented as evidence in the case.

What of if they appeal?

It's their discretion. It will be nice if they appeal because it will deepen the copyright fight in Nigeria and open up a lot of things. My name is already written in gold and my case will be cited in the weekly law reports. Its like a victory for the industry not just for Orits Wiliki.



Why did you choose to honor some industry veterans during your 40th year anniversary celebration onstage?

Today, in Nigeria, they only recognize you when you have died. This is the only country they dont appreciate you when you are alive, I felt this cannot happen in my time and so, every end of the decade I must give thanks and celebrate myself. If no one celebrates me, it will be nice for me to celebrate myself.

The 30 years anniversary was big and the 40 years was bigger. I said, I cannot celebrate myself alone, let me celebrate my constituency also. That was the idea behind celebrating my senior colleagues and others.
