Who Holds The Power? Nigeria's Shifting Political Alliances

s Nigeria's political stage heats up, the nation is witnessing a wave of shifting alliances that could redefine its power dynamics. In a landscape

where loyalty often bows to opportunity, political heavy-weights and rising stars alike are recalibrating their positions ahead of pivotal elections. The question dominating conversations across the country is clear: who truly holds the power?

Recent defections, coalition talks, and behind-thescenes negotiations suggest that Nigeria's political structure is in flux. Legislators from both the ruling and opposition camps have been crossing party lines, spurred by discontent, strategic posi-

tioning, or the search for internal rifts. High-profile greener pastures. For many, these movements are less about ideology and more about political survival in an unpredictable environment. At the heart of this shift-

ing landscape is the ruling party, which faces growing

disagreements over key policies such as subsidy removal, rising inflation, and the ongoing fuel crisis have exposed cracks in the party's unity. While it continues to maintain a legislative majority, murmurs of

current administration. However, unity remains a challenge. Efforts to forge a mega-coalition are under-way, but deep-seated rivalries and competing ambitions have slowed progress. "The opposition has an opportunity to seize power, but only if it can present a united front," said political analyst Dr. Aisha Garba. "Right now, they are still working out the terms of their marriage of convenience.'

Regional dynamics further complicate the picture. In the south, governors and political leaders are consolidating their influence, aiming to challenge northern dominance in national politics. In the north, traditional rulers and political stalwarts are leveraging their cultural and religious authority to maintain their hold on power. These regional power plays highlight Nigeria's enduring struggle to balance national unity with diverse local interests.

Amid these shifts, the electorate is growing rest-less. Many Nigerians view the ongoing realignments as a distraction from urgent ational issues including insecurity, unemployment, and worsening economic conditions. "The politicians are busy playing games while ordinary people are suffering," lamented a civil servant in Kaduna. "We need leaders who care about the people, not just their next election." said Abubakar Musa. As the 2027 elections draw closer, the stakes are higher than ever. Both the ruling party and the opposition understand that their future hinges on these shifting alliances. The question remains: will these political maneuvers lead to meaningful change, or will they per-

petuate the cycle of selfinterest that has defined Nigerian politics for decades?

For now, the chessboard is set, and the players are making their moves. Nigerians can only watch and hope that the eventual victors will wield their power in service of the nation, not just themselves.

Speaking on this development, a Political Analyst, John Atabo said; "with the 2027 general elections on the horizon, the question of who holds the power has never been more pertinent. In my analysis, what we are witnessing is not merely a series of defections, but a fundamental recalibration of Nigeria's political dynamics, where the lines between the ruling party, opposition, and regional interests are becoming increasingly blurred.'

According to him, "most striking feature of Nigeria's political realignment is the intensifying fragmentation within the ruling party. Despite its hold on power, the ruling party faces a grow-ing number of internal divisions, largely driven by dissatisfaction with the administration's handling of critical issues such as fuel subsidy removal, the state of the economy, and rising insecurity. These fractures are not just about policy disagreements; they reflect deeper tensions over the distribution of power, resources, and influence within the party itself. As the leadership struggles to maintain a united front, defections from within the party are inevitable. Several key figures, sensing the shifting winds, have begun to reposition themselves for the upcoming electoral cycle, either by distancing themselves from the administration or seeking new alliances with other political forces."

However, he continued, "the opposition, while opportunistic, faces its own set of challenges. Despite the growing discontent with the current government, the opposition has failed to present a cohesive and unified alternative. Instead, we see political fragmentation with competing factions vying for dominance. The recent efforts to form coalitions, aimed at challenging the ruling party in 2027, have been hampered by personal rivalries, divergent regional interests, and ideological differences. Unlike in past elections, where opposition parties were merely reactive, the current environment demands that they evolve into a credible, unified force capable of offering a clear policy agenda to the Nigerian electorate. Without that cohesion, the opposition risks being nothing more than a collection of disgruntled voices rather than a genuine challenger for power."

"The regional dynamics also cannot be ignored. In Nigeria, political power is often tied to geographical influence, and the shifting alliances we are witnessing are a reflection of this reality. Southern leaders, frustrated by the perceived marginalization of their region, are consolidating power to assert their political relevance, particularly with the 2027 elections in mind. Similarly, northern power brokers are holding firm, leveraging their entrenched influence in the nation's political and economic sectors. These regional power plays are shaping alliances and reshaping party affiliations in ways that are not easily predictable. As such, the role of traditional rulers, governors, and ethnic groups cannot be downplayed in the determination of who will ultimately hold the power."

He noted.

He pointed out that "to the average Nigerian, these shifting alliances raise legitimate concerns. There is growing frustration over the self-serving nature of political elites, with many feeling disconnected from the real issues affecting the country, such as insecurity, unemployment, and inflation. The political class, preoccupied with maneuvering for power, appears to have lost sight of the urgent need for governance that addresses the needs of the people. The electorate is increasingly cynical, yet hopeful that the right coalition of political forces will emerge to bring about meaningful change.'

Also Speaking on this issue, a Public Affairs Commentator, Abubakar Musa disclosed that, "in Nigeria's ever-evolving political landscape, the question of who holds the power has become more fluid than ever before. As the country navigates a complex web of shifting alliances, defections, and recalibrations, it is clear that political power in Nigeria is no longer concentrated in the hands of a single party or a few power brokers. Instead, it is a dynamic and fragmented force, wi giances are constantly being tested, and the true seat of power is anything but certain.' According to him, "at the heart of the current political shifts is the ruling party, which, despite holding the reins of governance, is increasingly experiencing fractures within its ranks. The discontent that has been brewing over the administration's handling of critical issues such as economic hardship, fuel scarcity, and the rising insecurity has now manifested in defections from key party members. What we are witnessing is not just a typical

case of political opportunism but an indication of a deeper dissatisfaction with the direction the party is headed. These defections, although framed as strategic moves, are a reflection of the growing disillusionment within the ruling party, especially as it becomes clear that the unity that once held it together is rapidly eroding."

"This internal crisis is significant because it exposes a critical weakness in the current government: the inability to consolidate its support base amid a challenging national landscape. It's not just about public criticism; it's about how political loyalty, once thought to be unshakeable, is now malleable as individual interests take precedence over party loyalty. The ruling party's inability to bridge these internal divides means that the power dynamics within the party are shifting, with factions seeking to assert themselves as the true standard-bearers of the administration's legacy." He said.

Continuing, he stated that, "in the other side of the political spectrum, the opposition is eagerly eyeing these divides, making national cracks in the ruling party's cohesion more difficult to structure. However, they too achieve." He added. significant challenges. While the opposition is united in its critique of the ruling party, it remains deeply divided internally, with various factions jockeying for dominance. Efforts to build a formidable coalition have been repeatedly stymied by infighting and disagreements over leadership and policy direction. As much as the opposition sees an opportunity to capitalize on the ruling party's internal turmoil, it must first address its own fragmentation. The question, therefore, is not just whether the opposition can unite against a weakened ruling party, but whether it can offer a cohe-

sive and appealing vision for the future of Nigeria."

Also, he disclosed that, beyond party politics, regional dynamics are also playing a pivotal role in Nigeria's shifting alliances. In a country as diverse as Nigeria, regional interests often influence national politics in ways that cannot be ignored. We are seeing southern leaders rallying around the need for greater regional autonomy and economic opportunity, while northern political heavyweights continue to exercise their historical influence over key sectors of power. These regional interests complicate the already fractured political atmosphere, as leaders strive to ensure their regions are not left out of the decisionmaking process.'

"The growing emphasis on regional power underscores the need for a more inclusive political process that reflects the diverse aspirations of Nigeria's many ethnic and cultural groups. Without this inclusivity, the shifting alliances and power struggles we are witnessing may deepen existing

For the Nigerian elector ate, these shifting alliances are both confusing and frustrating. Many Nigerians are left questioning whether their leaders are genuinely concerned with the welfare of the people, or simply engaged in a game of political maneuvering. The increasing sense of disillusionment among the populace cannot be ignored. Voters are weary of a political class that seems more interested in maintaining power than addressing the pressing issues of the day-economic hardship, unemployment, and security challenges.

Abuja-Kaduna-Kano Road Ready In 14 Months – FG

he Minister of Information and National Orientation, Mohammed Idris, has said that the Abuja-Kaduna-Kano dual carriageway will be ready for use in 14 months.

Idris made this known at the inauguration of the rehabilitation of section 1 of the road (Abuja to Kaduna) rigid pavement on Thursday.

While Section 1 of the road is from Abuja to Kaduna, Section 2 is from Kaduna to Zaria, and Section 3 is from Zaria to Kano.

The description and

"This is the reason the government cancelled the road contract with the former contractor who said it would complete the road in three years and the govern-

"That is also why it was broken into three segments for ease of construction. Nigerians, especially those plying this road, are anxious to see that the road is completed," he said.

He said that delay of any kind would not be accepted.

"The President has given a matching order, and the National Assembly is also given them the necessary cooperation and there will be no issues.

Within 14 months, we are going to have a brand new road from Abuja end to Kano," Idris said.

We Don't Need Your Help For Tinubu's Economic Reforms, FG Replies Emir Sanusi

he federal government has reacted to a recent remark by the Emir of Kano, Muhammadu Sanusi II, who expressed his unwillingness to help the current administration of President Bola Ahmed Tinubu on addressing the country's economic challenges.

The Emir, at a public event in Lagos recently, stated his resolve not to speak on solutions to the effects of some of the economic policies by the current administration.

But the federal government, in a statement on Thursday, signed by the Minister of Information and National Orientation, Mohammed Idris, said the Tinubu-led federal government doesn't need the stamp of approval of Emir Sanusi on its "laudable policies".

According to the statement, even though the Emir, like every other Nigerians, has the right to express their opinion in form of condemnation or criticism, the federal government expressed dismay 'that a leader, more so one from an institution that ennobles forthrightness, fairness, and justice would publicly admit to shuffling off saying the truth because of personal interest hinged on imaginary antagonism."

he Ogbakor Ikwerre Cultural Organisation Worldwide, the apex decision-making body of the Ikwerre ethnic nationality in Rivers State, has announced the withdrawal of all honours, recognitions, and titles previously bestowed on Senator John Azuta-Mbata, the newly ted Pre

in Ikwerre land, including community meetings and political representation.

This decision extends to his hometown, Eneka Community in Apara Kingdom.

The Ikwerre leadership accused Azuta-Mbata of committing "sacrilege" against Ikwerre land by accepting the leadership of Ohanaeze Ndigbo, a socio-cultural orgamzauon representing the igo In their view, his decision signifies a renunciation of his Ikwerre identity, rendering him "a total stranger" in the community. In a statement jointly signed by the President General of Ógbakor Ikwerre Cultural Organisation Worldwide, Eze Barr. Godspower Onuekwa, and Secretary General, Barr. Nyebuchi Philips, the group expressed strong disapproval of Azuta-Mbata's actions: "By becoming the President-General of Ohanaeze Ndigbo, Senator John Azuta-Mbata has willingly and freely renounced his membership and identity as an Ikwerre person (Iwhuruohna).

NGF Okays Revised VAT Sharing Formula To Promote Equity

he Nigeria Governors' Forum (NGF) has given nod to a revised Value Added Tax (VAT) sharing formula aimed at promoting equitable resource distribution among states.

The new formula assigns 50 percent based on equality, 30 percent based on derivation and 20 percent based on population.

This decision was arrived at at the end of the Subnational Consultations and Engagement Presidential Tax Reform Committee, according to a communique issued by chairman of the

issues, including the reform of Nigeria's fiscal policies and tax system, and arrived at the following resolutions:

The Forum reiterated its strong support for the comprehensive reform of Nigeria's archaic tax laws. Members acknowledged the importance of modernizing the tax system to enhance fiscal stability and align with global best practices.

The Forum endorsed a revised Value Added Tax (VAT) sharing formula to ensure equitable distribution of resources: 50 percent based on equality, 30 percent based on derivation, and 20 percent based on population. Members agreed that there should be no increase in the VAT rate or reduction in Corporate Income Tax (CIT) at this time, to maintain economic stability. The Forum advocated for the continued exemption of essential goods and agricultural produce from VAT to safeguard the welfare of citizens and promote agricultural productivity. The meeting recommended that there should be no terminal clause for TETFund, NASENI, and NITDA in the sharing of development levies in the bills.

Suspends USSD For Nine Banks: Full List

he Nigerian Communications Commis-sion (NCC) has approved telcos' decision to suspend USSD services for nine banks due to an accumulated debt of N160 billion since 2019.

The banks affected include Fidelity Bank Plc, First City Monument Bank, Jaiz Bank Plc, Polaris Bank Limited, Sterling Bank Limited, United Bank for Africa Plc, Unity Bank Plc, Wema Bank Plc, and Zenith Bank Plc.

The use of Unstructured Supplementary Service Data (USSD) platform has been crucial to the Central Bank of Nigeria's (CBN) push for a cashless economy. USSD allows bank customers to access financial services on their phones without the need for the internet. However, this initiative is threatened due to ongoing disputes over outstanding debts between Mobile Network Operators (MNOs) and Deposit Money Banks (DMBs). Since 2019, nine banks have been unable to settle an accumulated debt of N160 billion. Initially, the list consisted of 18 banks before the Nigerian Communications Commission (NCC) announced that nine of these banks had paid, while another nine had yet to pay. The nine bank customers yet to pay now face being cut off from USSD services by Monday, January 27, 2025.

FG Plans To Raise N1.8tn From Bond Market In Q1 2025

he Federal Government plans to raise N1.8 trillion from the bond market in the first quarter of 2025, as announced by the Debt Management Office. The newly released FGN Bond Issuance Calendar outlines a mix of reopened and new bonds to be auctioned in January, February, and March 2025.

This initiative is part of the government's strategy to address a projected budget deficit of N13.08 trillion in 2025, which is 3.87% of the country's Gross Domestic Product. The bonds will be crucial for financing essential infrastructure and addressing fiscal gaps.

The bond calendar includes the re-opening of the 19.30% FGN ÂPR 2029 bond, with a remaining tenor of four years and three months. The government plans to offer between N150 billion and N200 billion in each of the three auctions, making this bond a key component of the overall program.

Similarly, the 18.50% FGN FEB 2031 bond, with a tenor of six years and one month as of January 2025, will also be re-opened and

By Anyanwu Theresa offered within the same range of N150 billion to N200 billion per auction.

Additionally, a new bond, the FGN JAN 2035, will be introduced to the market, targeting investors interested in longer-term instruments. This bond, with an original tenor of 10 years, will also be offered within the N150 billion to N200 billion range.

If the government reaches the upper limit of the offer range across all three auctions, it could raise up to N1.8 trillion by the end of the quarter. The auctions are scheduled for January 27, February 24, and March 24, 2025.

Although the calendar is subject to change, this structured approach demonstrates the government's commitment to transparency and predictability in meeting its financing needs.

In 2024, the Federal Government borrowed an estimated N5.84 trillion from the FGN bond market to bridge its 2024 budget deficit. This figure represents a 0.17% decline compared to the N5.85 trillion borrowed in 2023 through the Debt Management Office. Total subscription to FGN bonds was N7.09 trillion in 2024, despite a total offer of N5.72 trillion.

FCT's Move To collect Council **Revenue Stirs Protests**

entre for Reform and Public Advocacy has kicked against moves by the Federal Capital Terri-tory Internal Revenue Service (FCT-IRS) to collect all revenues on behalf of the six area councils of the FCT in 2025.

The centre, in a statement, argued that the move was unconstitutional, illegal and unlawful. According to the statement released, recently, in Abuja by its Head, Legal Unit, Mr Kalu Agu Kalu, the FCT-IRS ACT, 2015 limits the powers of the service to collect such revenues for the Federal Capital TerritoryAdministration.

"For the purposes of clarity and emphasis, the six area councils are not departments of Federal Capital Territory Administration, but a third tier of Government, constitutionally enshrined and established, and whose functions and powers are delineated by the same Constitution.

"While the Supreme Court had granted autonomy to area councils/local governments, it is laughable that the acting Chairman of the FCT-IRS, Mr Michael Ango, seeks to undermine the pronouncement of the Supreme Court by usurping the powers and functions of the area councils, with a total disregard to the Constitution and the law," the group said.

Ango had announced at the 2024 end of year media briefing in Abuja that FCT-IRS would be responsible for the collection of all revenues on behalf of the six area councils of the FCT in 2025.

He said the goal was to ease compliance by taxpay-ers in the FCT and improve transparency and account-ability for all revenue collection. He said that a similar arrangement was being worked out with the various secretariats, departments and agencies in the FCT Administration.

He explained that the decision was in compliance with the directive of the FCT Minister, MrNyesom Wike.

But while reacting to the announcement, the Advo-cacy Group said: "There is no provision in the FCT-IRS that empowers the FCT–IRS to collect revenues on behalf of the six area councils.

"Maybe Mr Michael Ango does not know that all the revenues he intends to collect on behalf of the six area councils on the "directive" of the 'Almighty Wike' are functions of the provisions of the Fourth Schedule to the 1999 Constitution of the Federal Republic of Nige-ria (as altered), which were undoubtedly donated to the six area councils, but we must forgive him because he is ignorant.

'May we, at this juncture, draw the attention of the acting Executive Chairman of the FCT-IRS to Section 2 of the Taxes and Levies (approved list for collection) Act, LFN, 2004, which makes the collection of revenue by unauthorised persons as a criminal offence.

"The said Taxes and Levies Act clearly sets clear boundaries on revenues the Acting Executive Chairman of the FCT – IRS and his Almighty Wike should col-lect and should not in any guise dive into other revenue collection not donated to the Federal Capital Territory.

"Let us also use this medium to place it on record that the Centre for Reform and Public Advocacy had already filed a civil suit against the Federal Capital Territory Internal Revenue Service at the High Court of the Federal Capital Territory, Abuja, seeking injunctive reliefs against the FCT-IRS from collecting any revenue on behalf of the six area councils.

Beggars, Others Sue Wike, Demands N500m Over Alleged Rights Violation

canvengers, beggars and other vulnerables Federal Capital Territory (FCT) Minister, Nyesom Wike, and demanded N500 million in damages for alleged breaches of their fundamental rights.

The lawyer argued that the way homeless people, scavengers, petty traders, beggars, and other vulnerable Nigerians in the FCT were being treated was a clear violation of their fundamental rights.

He claimed that arresting

detaining them without charges, and harassing them violated their rights.

He said their rights were guaranteed under Sections 34, 35, 41, and 42 of the Constitution of Nigeria 1999 (as altered).

Hikima, in his affidavit, said he witnessed a disturbing scene on November 12, 2024, around 11 pm, while he was passing through Ahmadu Bello Wayin Abuja.

According to him, he saw a joint task force, made up of security operatives and enforcement officers, including military and police personnel, arresting a group of people who appeared to be homeless, scavengers, and beggars.

Delta State Government Suspended SSA Over Alleged Fraudulent Activities

he Delta State Government has suspended Ms. Favour Obakoro, also known as Vida Modelo, the Senior Special Assistant (SSA) to the Governor on Morals and Diaspora Affairs, following allegations of fraudulent activities.

The suspension, announced through a statement signed by the Secretary to the State Government (SSG), Dr. Kingsley Eze Emu, is effective immediately. The decision is aimed at allowing security agencies to conduct a thorough investigation into the accusations againsther.

Obakoro, who has come under intense scrutiny in recent days, is accused of exploiting her position to fraudulently secure funds from individuals seeking work permits to work abroad. It is reported that she collected over N100 million from several victims, promising them legitimate work permits that were never delivered.

The allegations were first brought to light by Nigerian activist and social media influencer, Martins Vincent Otse, also known as VeryDarkMan. In a viral video, Otse accused Obakoro of using her office to scam people, particularly from the Diaspora, into paying large sums for fake work permits. He claimed that the victims were promised legitimate services but received nothing in return after making payments.

Some victims have come forward with specific details of their transactions, revealing amounts ranging from 1.5 million naira to 10 million naira. One victim reported sending 5 million naira, while others claimed that they transferred a total of over N70 million to Obakoro's personal account. Despite the payments, the victims were left without the

demand either their money back or the work permits, Obakoro allegedly used her influence to avoid fulfilling her commitments.

Disturbingly, some of the victims have produced recordings of phone conversations with Obakoro, in which she allegedly assured them that their requests would be fulfilled, using her official position to gain their trust. The revelations have sparked public outrage, with

promised documents, and many questioning the integ-when they attempted to rity of Obakoro's role within the government, especially given her association with Ğovernor Sheriff Oborevwori, who has recently been recognized for his positive contributions to the state's infrastructure and governance.

The suspension of Obakoro comes as a response to these grave allegations, and the government has pledged to fully cooperate with security agencies to ensure a thorough investiga tion. It is expected that further details will emerge as the inquiry progresses. Meanwhile, the reputation of Governor Oborevwori, who has been praised for his leadership and development initiatives, may be at risk if the claims are substantiated.

As the investigation unfolds, the Delta State Government has assured the public that any individuals found guilty of corruption or misconduct will be held accountable.

Eldest Son Of Nigeria's First Minister Of Finance Appeals To President Tinubu To Immortalize Father On Currency

he eldest son of Nigeria's first Minister of Finance, Chief Festus Samuel Okotie-Eboh, Prince John Edema Okotie-Eboh, has called on President Bola Ahmed Tinubu to honor his late father by engraving his portrait on the Nigerian currency.

Horror: Bird Flu Kill 32 Chickens In Kano - Dr. Raises Alarm

...warns against eating infected bird

wale Veterinary Hospital, Chief Medical Officer, Dr. Abdullahi Abubakar Gaya, has confirmed the death of 32 Chickens following an outbreak of bird flu in Gwale Local Government Area of Kano state.

Gaya who spoke to Journalists recently, cautioned residents against eating infected birds saying it has severe consequences on human health.

He confirmed that over 32 birds died of the outbreak in Kano recently, adding that investigations are still on to confirm whether more birds and humans have been affected.

Dr. Gaya narrated how a Chicken rearer brought the first case to the hospital arising from an infected guinea His birds are 50, majority fowl he purchased at have died and he slaughtered Janguza market without iso-

"Mixing of the infected Guinea fowl led to the death of over 32 other birds at the poultry with a population of over 50 birds. The poultry farmer reported the case to the hospital on December 7, 2024.

"After purchasing the Guinea fowl and mixing it with other birds, the Guinea fowl died; after which other chickens started dying one after the other" he stated.

Gaya warned that anybody who can consume affected birds that are slaughtered will develop health problems, pointing out that bird flu is a respiratory disease that is highly infectious.

Those who consume the birds that were slaughtered can become infected. Currently this particular index case is the only case we have. some.

ing. More information are underway. The general advise is that if you buy a bird, you need to isolate it.

"If you see a sign of sickness in a bird or any animal, report to the nearest veterinary hospital. If you see a dead bird, do not touch it, report to the nearest veterinary hospital. The disease is changing pattern. It is becoming serious," Dr. Gaya added.

Earlier, the Kano State Commissioner of Health, Dr. Abubakar Labaran Yusuf, said the Ministry has already taken charge of the situation, stopping the disease from spreading to other parts of the state.

"The bird flu virus was confirmed and the state Ministry of Agriculture took proactive measures to con-

Dr. Labaran Yusuf assured residents that the situation is under control adding that, "it is not severe enough to be declared an outbreak.'

'The ministry also decontaminated the premises where live birds are sold in the Janguza market and sensitized sellers on the effects of the bird flu.

"Surveillance will be intensified in every Local Government Area, especially among poultry and bird rearers, with daily reports sent to the committees" he stated.



Helen spoke with SAM ORJI on a number of issues pertaining to her career and family. Enjoy the interview

what's happening?

I have been doing some shows, sometimes I travel to do many things but you have to understand time and season. When it's the Christmas or November season sometimes, I make myself available for shows because I am around. So everything has their time and season. I have been doing some comedy shows because I am even producing my own

Are you no longer permanently based in Nigerian again?

I will say most entertainers are people that are not permanently based just in one place. The world is a global space, so when you're invited to different places you go. It's not necessary the audience know your house and home address and the family where you live, you just keep working. It's a global space.

You do more of soap operas than movies, why?

I am still doing movies; once I am given scripts, I do. Maybe we have not seen much of the work I have been shooting. I was in Nigeria, I think two months ago to shoot an indigenous movie in Ibadan. So, I am working and I am still active and when people call you, give you the script; you read and if it's something that you like, you take it.

Because you're a comedienne, most of the roles they give you are comic roles. They seem to have stereotyped you.

There's nothing like stereotyped. I think when they are casting they will look at the whole script and say this person can play this role. I have done Jacobs Mansion, where I was not a comedienne but a bride to the rich man finally. I have done other movies where I played the role of a child. As an actor they will look at you and cast you where they know you fit in very well.

Unless if you are doing your own movies, you can now use it to tell peo-ple that you can do this or that. It's not stereotyped but they believe that such a role is what you can do very well. They're aware that you are not just a comedienne; you have other aspects of your life. We all see Whoopi Goldberg; they will not give her a girlfriend role because they know she is very firm, we know the movie where she acted as an instructor, where she is firm and strong will. It's not only just in our country, I think when they're doing their casting they just feel because when you see some people, you see they are all around, they act like king's even in real life. They know because I have done many things I didn't do anything comic.

Legal Battle Unfolds: Oba Otudeko, First Bank, And General Hydrocarbons In High-Stakes Dispute

A high-stakes legal battle has emerged, drawing national attention as Oba Otudeko, Chairman of the Honeywell Group, First Bank of Nigeria (FBN), and General Hydrocarbons Limited (GHL) face off over allegations of fraud, contractual breaches, and financial mismanagement. At the heart of the dispute are claims involving billions of naira, raising questions about governance, transparency, and accountability in Nigeria's financial and business sectors.

The Allegations

The Economic and Financial Crimes Commission (EFCC) has filed multiple charges against Oba Otudeko and several other defendants, alleging that they fraudulently obtained N12.3 billion from First Bank between 2013 and 2014. The charges include securing N6.2 billion in credit facilities under false pretenses and allegations of money laundering.

One charge reads: "That you, CHIEF OBA OTUDEKO, STE-PHEN OLABISI ONASANYA, SOJI AKINTAYO, AND ANCHORAGE LEISURE LIM-ITED, on or about the 26th day of November 2013 in Lagos, within the jurisdiction of this Honourable Court, conspired amongst yourselves to use the total sum of N6,150,000,000 (Six Billion, One Hundred and Fifty Million Naira Only), which you reasonably ought to have known forms part of proceeds of your unlawful activities.

Another charge alleges: "That you, CHIEF OBAOTUDEKO, STE-PHEN OLABISI ONASANYA, SOJI AKINTAYO, AND ANCHORAGE LEISURE LIM-ITED, on or about the 11th day of December 2013 in Lagos, within the jurisdiction of this Honourable Court, procured Honeywell Flour Mills Plc to retain the sum of N1,500,000,000 (One Billion, Five Hundred Million Naira Only), which sum you reasonably ought to have known forms part of proceeds of your unlawful activities, to wit: Obtaining by False Pretense. You thereby committed an offence contrary to Section 18(c) and of the Money

First Bank's Position First Bank has aggressively

defended its actions, stating that it initiated legal proceedings to protect its interests and recover loans extended to GHL. In a statement, the bank accused GHL of breaching loan agreements by diverting crude oil sale proceeds earmarked for loan repayment.

"FirstBank has diligently performed its obligations under the robust loan agreements executed with General Hydrocarbons Limited. Unfortunately, GHL rejected demands for accountability and transparency, which were aimed at safeguarding stakeholder interests," the bank noted.

The bank claimed further violations occurred when GHL requested additional funding without meeting prior obligations. To address these issues, First Bank proposed appointing an independent operator for better oversight, a move met with resistance from GHL.

FirttBank further clarified, "With regards to the reported claims, Dr. Oba Otudeko would like to clarify that he has never served in an executive capacity within FBN Holdings and its banking subsidiary, First Bank of Nigeria Limited and as such has had no operational responsibility in the organisation". scape, adding that he remains confident the truth will prevail.

"He has built directly from scratch and has worked with others to build many of Nigeria's most successful companies. These include FBN Holdings, where he served as Chairman from 1997 to 2021, supporting its transformation into a pan-African financial services holding company," the statement read.

Legal Proceedings and Testimonies

Representatives from the Central Bank of Nigeria (CBN) and First Bank of Nigeria (FBN), along with other witnesses, have been listed to testify against Oba Otudeko and former FBN Managing Director, Olabisi Onasanya, in the alleged N12.3 billion fraud case.

The prosecution intends to call the following witnesses to testify and present evidence: Investigators from the EFCC

Representatives of V-Tech Dynamics Links Limited, Representatives of Stallion Nigeria Limited, Representatives of First Bank,

Representatives of the Central Bank of Nigeria (Directorate of Banking Supervision) to provide evidence on the measures taken to uncover the alleged fraud.

Channels Television reports that the defendants are scheduled to be arraigned on Monday, January 20, before Justice Chukwuejekwu Aneke of the Federal High Court, Lagos.

A Federal High Court has issued a series of orders, including Mareva injunctions, to freeze assets and accounts linked to General Hydrocarbons Limited, its affiliates, and prominent individuals, including media mogul Nduka Obaigbena. The court's decision follows allegations of unpaid loans totaling \$225.8 million, owed to a financial institution. The injunctions were granted to prevent the defendants from transferring or dissipating assets while a legal dispute over unpaid loan facilities is resolved. claims.


This case represents more than a dispute over unpaid loans; it is a test of Nigeria's legal and financial systems in handling allegations of corporate malpractice. The court's decision will have significant ramifications for the banking sector, business transparency, and the individuals involved.

Also, FirstBank alleged that GHL diverted proceeds from crude oilsales that were meant to serve as repayment for the loans. To address these breaches, the bank proposed appointing an independent operator to ensure better oversight of the financed assets. However, this suggestion was met with resistance. The bank further claimed that GHL escalated the situation by demanding additional funding without fulfilling its prior obligations.

In response to the allegations, Dr. Oba Otudeko has firmly refuted the claims regarding his role in FBN Holdings. A statement signed by Olasumbo Abolaji, General Counsel at Honeywell Group, emphasized Dr. Otudeko's contributions to Nigeria's business landscape. The statement reads, "He has built directly from scratch and has worked with others to build many of Nigeria's most successful companies. This includes FBN Holdings, where he served as a director (then Chairman) from 1997 to 2021 and was instrumental in supporting the transformation of the bank from an old generation bank to its current leadership role as a pan-African financial services holding company".

The court directed all major commercial banks and financial institutions in Nigeria to block the defendants' accounts and restrict access to funds or assets up to the claim amount, pending further legal proceedings. The injunctions restrain bankslike GTBank, Access Bank, Zenith Bank, First Bank, and fintech platforms such as Flutterwave, Paystack, and Piggyvest from releasing funds or handling assets linked to the defendants.

The legal dispute involving Oba Otudeko, FBN, and GHL is a comlex and multifaceted case th significant implications for all parties involved. Dr. Otudeko has expressed confidence that the truth will prevail and looks forward to addressing these claims in the appropriate forum. As the case progresses, testimonies from CBN and First Bank staff, along with the court's decisions, will play a crucial role in determining the outcome of this high-profile legal battle. As Justice Chukwuejekwu Aneke prepares to hear the case on January 20, the nation watches closely. Will this legal battle clarify the lines of accountability in corporate Nigeria, or will it raise further questions about governance and oversight in the country's financial institutions? 



have investigated and research on you. I have not had such experience with any corporate organization and I have been doing great work for them. I do a lot of corporate events, conferences, award ceremonies, staff appreciation services and do many corporate events. I have not had such issues with them.

Do you think the movie industry has done well to attract the likes of Amazon, Netflix and others to invest in Nigeria motion picture industry?

What I like about them is that they are not sentimental, they are business people and for them to tap into Nollywood that means there's more we have that's doing well. Yes, I will say we're improving for them to keep coming to us. We are improving in our storytelling techniques from the camera angle, editing, directing style, presentation by actors and I think the movie industry is doing well, showcasing the country and improving in every aspect. We will keep improving; I am not saying that we are now perfect.

You travelled abroad and seen how movies are produced. Compare it with what is happening here, where are we getting it

happening?

I don't feel that someone will just come and take over like that. It's also the same with you as a writer and I have known you for years as a writer. Can we ask, why are the young writers not taking over from you? There's nothing like taking over because everyone is growing and don't forget that now the young and the old are now collaborating. There are young people coming up, doing great works, it's just to see how we celebrate them more. There are many people; we have lots of other ladies.

They might not use the same style or technique. They might not just be stand-up comedy, there are still other means they crack jokes and they are doing very well and we add different elements to these things. We are using the same elements but speaking in different ways. I will not agree that we have old people, how old I am that you will say I am old. I am not old. We started long time ago but I am still very young and the other ladies are still doing well.

You can't say one has killed the other because they are not in the same level. You cannot watch live stand-up comedy from the comfort of your room. You go to the theatre to see the show, except if they are streaming it live which is what a lot of them are doing now. We have comedians doing their shows and they are streaming it live through the social media platforms, Facebook, Instagram, Twitter and some even go through TV stations where they will be streaming live and

you watch. They're different but the main goal is to make people laugh, entertain, educate and inform.

An older comedian said the young ones are just picking and refining their jokes. Most of them just climb the stage to insult people in the name of jokes. Have you observed that too?

I think that's his own personal opinion and the shows he has attended. I carefully select where I go and the people I relate with, we don't have that issue. Maybe that's what he encountered the place he has been to. Explaining his reasons for not returning to the NPFL, Omeruo cited the absence of a top-flight club in his hometown of Abuja.

He said, "I don't see myself going back to the Nigerian league to play, but I'm passionate about scouting good players, "Omeruo noted.

However, Omeruo's passion for Nige-

 \neg uper Eagles defender Kenneth rian football remains strong, particularly when it comes to identifying and nurturing youngtalent.

He recalled a time when an NPFL streaming app allowed him to share game footage with his agent and others, highlight-ing the quality within the league.

There was a time when the league had an app where we could stream games from everywhere and back then I shared it (the link) with my agent and other people because I knew the quality we had in that league," he explained.

The former Chelsea player ruled out playing in Nigeria's League but the presence of prominent Nigerian internationals like Ahmed Musa, Shehu Abdullahi and Brown Ideye in the NPFL could still inspire other stars to follow suit.

on Musk's father, Errol Musk, has revealed that his billionaire son is interested in buying Liverpool FC. The Premier League club is currently owned by Fenway Sports Group (FSG), which has not indicated any plans to sell. In an interview with Times Radio, Errol Musk said, "Oh yes, but that doesn't mean he's buying it.

He would like to, yes, obviously, anybody would want to. So would I." However, an FSG spokesperson dismissed the rumors, stating, "There is no truth to these rumors." In September 2023, FSG sold a minority stake to U.S. investment firm Dynasty Equity, but has shown no intention of selling a majority stake. FSG president Mike Gordon said, "Our long-term commitment to Liverpool remains as strong as ever.

Errol Musk also mentioned personal connections to Liverpool, hinting at family ties and even a historical connection with The Beatles. If Elon Musk were to acquire Liver-pool FC, it could lead to significant changes at the club. As one of the world's wealthiest individuals, Musk would have the financial resources to make major investments in the team. However, any fundamental changes to the club's traditions or operations would likely face scrutiny from loyal supporters. Liverpool fans have a deep-seated loyalty and have been vocal about their expectations from the owners. The speculation surrounding Musk's potential ownership has generated a mix of excitement and apprehension among the fan base. While some fans are intrigued by the possibility of new investments and changes, others are concerned about the impact on the club's legacy and traditions. As the rumors continue to circulate, the football world will be watching closely to see how these developments unfold and what impact they may have on one of the most storied clubs in the sport's history.

Under FSG's ownership, Liverpool FC has regained its status as one of Europe's top clubs. The team won its first English league title in 30 years in 2020, one season after winning the Champions League.
