presiding Judge, Justice Hilary I. O. Oshomah held that Odefa had "maliciously" used the police against the defendants by making criminal accusations against the applicants in a civil political

The court held that his statement to the police that the defendants forged documents to suspend him as a member of the PDP in Oguduokwor Ward failed to show proof of any form of forgery in the court to support his

Odefa who had alleged in issued an order restraining Odefa and the police from harassing, arresting or in any form intimidating the defendants on the issue of his suspension from the PDP, Oguduokwor Ward.

The court, therefore, 000 (five million naira) to each of the 20 defendants totaling N100, 000,000 (one hundred million).

The court further ordered that the cost must be paid within seven (7) days of the judgement, failure to pay, according to the court will attract 10%

daily interest.

At the ruling, the OC Legal of the Nigeria Police, Ebonyi State Command, Benson Emenike was in the court to represent the Commissioner of Police, while Odefa's counsel was absent despite receiving earlier sitting notice from the court.

Political Analyst, Richard Oigocho said; "the cost

not just a financial issue; it is a reflection of our priorities as a nation. When you look at the size of our government, from the executive to the legislative arms, it's clear that we have created a system that prioritizes the comfort of the political elite over the welfare of the people."

According to him, "Nigeria's political structure is riddled with inefficiencies. The recurrent expenditure, which accounts for the bulk of our budget, is primarily used to fund salaries, allowances, and perks for government officials. Yet, these same officials preside over a nation struggling with poverty, unemploy-ment, and failing infrastructure. How do we justify such a mismatch?"

"What's even more troubling is the trickle-down effect on ordinary Nigerians. The average citizen pays the ultimate price for this unsustainable system-through higher taxes,

of governance in Nigeria is reduced social services, and worsening living conditions. Every naira diverted to fund excessive government spending is a naira taken away from critical sectors like education, healthcare, and power." He

> Moreover, he continued, "the absence of accountability fuels this crisis. Corruption and wasteful spending thrive in the absence of stringent checks and balances. Without transparency, citizens are left in the dark about how their taxes are being used, and leaders face little pressure to act responsibly.

> To change this narrative, he pointed out that, "we need bold reforms. Reducing the size of government, cutting down on allowances, and implementing stringent fiscal policies are necessary steps. Equally important is fostering a culture of accountability where public officials are held responsible for their actions.

Until we address this imbalance, the gap between the government and the governed will continue to widen, leaving citizens to pay a steep price for a system that serves only a privileged few." He added.

Also speaking, a Public Affairs Analyst, Samuel Eze, said; "the cost of governance in Nigeria has reached an unsustainable level, and the burden falls squarely on the shoulders of ordinary citizens. While the political elite enjoy the perks of oversized bureaucracies, excessive allowances, and lavish lifestyles, the masses are left to grapple with the fallout—rising inflation, inadequate social services, and dwindling opportunities."

According to him, Nigeria's political system, designed to serve the people, has instead become an

the national budget to recurrent expenditures, including the maintenance of public offices, security votes, and unnecessary committees, leaves little for capital projects. The result? Poor infrastructure, failing healthcare systems, and a deteriorating educational sector.'

According to him, what is particularly troubling is the lack of transparency and accountability. The average Nigerian cannot fully comprehend how much is spent on governance because the process is shrouded in secrecy. Meanwhile, the political class justifies these expenditures by citing the complexity of governing a diverse nation. But should diversity come at such a staggering cost?"

> Speaking about solutions, he pointed out that, "solution lies in bold reforms. We need to reduce the size of government, streamline administrative processes, and cut down on wastage. More importantly, we must demand transparency and accountability from our leaders. Governance must shift from being a burden to becoming a tool for sustainable development."

> "If this systemic waste continues unchecked, the gap between the government and the governed will only widen, creating a nation where a few thrive at the expense of the majority. The time for action is now.

Kaduna Primary Teachers Decry Hardship Over Non-Implementation Of Minimum Wage

rimary School Teachers (PTS) in Kaduna State have cried out for severe hardship over non implementation of new minimum wage in the state

They disclosed this in an open letter addressed to President Bola Ahmad Tinubu, dated Thursday 23rd January, 2025, and made available to journalist in journalist in Kaduna.

"We, the primary school teachers of Kaduna State, humbly write to bring to your attention the ongoing hard-ship we face due to the nonimplementation of the new minimum wage in our state.

"Despite the federal government's progressive step to increase the national minimum wage to N70,000, we, the teachers responsible for shaping the future of our nation, have been excluded

"Primary school education forms the bedrock of Nigeria's development, yet the failure to adopt the new minimum wage in Kaduna State leaves us struggling to meet basic needs and demotivated in carrying out our duties.

The impact of this neglect extends beyond our personal lives, as it compromises the quality of education we provide to the children entrusted to our care.

"Your Excellency, we appeal to you as the leader of our great nation to intervene and ensure that the Kaduna State government fulfills its obligation to implement the minimum wage for all pri-mary school teachers", the letterstated.

Signed by Concerned PSTs of Kaduna State, (for fear of victimization), the teachers recommend three actions for immediate

Implementation amongst others, including urging federal government to Issue a directive to the Kaduna State government to immediately implement the new minimum wage for all primary school teachers.

Titled: "Dear Mr. President: Non-Implementation of New Minimum Wage in Kaduna State", PST also urged for timely payment when implemented and ensure that teachers' salaries are paid regularly to alleviate financial strain and foster a motivated workforce.

Accordingly, they also called for Accountability Mechanism Enforce and accountability for local government chairmen to ensure compliance with the federal

'Additionally, we suggest the following consequences for non-compliance: Sanctions: Impose administrative or financial penalties on local government officials who fail to implement the minimum

wage.
"Leadership Review: ment chairman who consistently neglects this responsibility, ensuring that commit-ted and capable leaders are in

"Mr. President, your intervention will not only alleviate our financial burdens but also restore our confidence in the federal government's dedication to justice and equity.

"By addressing this issue, you will reaffirm the critical importance of education and the teachers who provide it in building a brighter future for Nigeria.

'We remain hopeful and trust in your commitment to ensuring a fair and prosperous Nigeria for all.

Thank you for your attention and timely action on this matter", it stated.

Alleged N33.8bn Fraud: How I Received More Than N22bn From Power Ministry-BDC Operator

he trial of former Minister of Power, Saleh Mamman continued on Wednesday, January 22, 2025 at the Federal High Court, Abuja, pre-sided over by Justice James Omotosho with the Economic and Financial Crimes Commission, EFCC presenting its 8th witness, PW8.

The witness, PW8 Abdullahi Suleman, a bureau de change operator, narrated how more than N22 billion was allegedly siphoned from the Federal Ministry of Power while Mamman was Minister. He said the naira equivalent of the money was exchanged for United States dollars through his business accounts.

Mamman is being prosecuted by the EFCC on a 12-count charge bordering on conspiracy to commit money laundering to the tune N33,804,830,503.73 (Thirty-three Billion, Eight Hundred and Four Million, Eight Hundred and Thirty Thousand, Five Hundred and Three Naira, Seventythree Kobo).

At Wednesday's proceedings, Suleiman, while being led in evidence by prosecution counsel, Rotimi Oyedepo, SAN narrated that about 12 of his business accounts received money from the Federal Ministry of Power without carrying out any service, contact or project. His com-panies; Prymint Investment Limited, Strong Field International Projects Limited, Mintedge Nigeria Limited, First Class Construction and Project, Silverline Ocean Ventures, Golden Bond Nigeria Limited, Sipikin Global Enterprise, Spinhiills Biz International limited, Fullest Utility Concepts Limited, Platinum Touch Enterprises, Breathable Investment Limited and a company owned by his brother named Gurupche Business Enterprises were used for the transactions.

"I know Alhaji Maina Goje, we are in the same business, sometimes in 2019, Maina Goje met me that he has transaction that I should give him some of my account numbers, the first account I gave him was Fullest, he will send money and I will give him dollars, he started asking for more accounts, he will tell me what to do with the transactions, I will get the dollar and give him and sometimes I will do a transfer to other accounts. We have been working together since then till 2024. From my rough calculations, the amount I have received through the transactions will be more than 22 billion naira. Also Maina used to send someone called Musbhu anytime he was not available, he would send him and give me instructions on what to do with him, we do call him Yaro Minister because he is from Saleh Mamman", he

Continuing, " I also know Mr Mustapha Muhammed, Goje told me that he is his oga, I didn't know him before until Maina Goje introduced him to me, then I learnt he works with Federal Ministry of Housing and instructed that anytime they can't reach him, I should give him the amount of dollars he requested"

"Look at the robust engagements with all stakeholders..., and it is not just engagement like a tea party affair, all the ideas and resolutions brought in by stakeholders are what the NDDC is using to work, and so the people now have a say on how they want their areas to be developed – these are the things endearing people to this Tinubu's government.

"Don't forget, people were thinking the NDDC would be run based on political party affiliation – where it is just a party thing and only members of the APC will benefit, but Ogbuku is carrying everybody along irrespective of their political parties.

"Also, look at the stakeholders, the ethnic nationalities – the Ogbuku-led NDDC is touching every facet of the society, none is left behind. Even the youths, none is left behind – all shades of the youth bodies are being carried along."

Court Grants EFCC's Move to Amend Charges Against Agunloye Over The \$6b Fraud Allegations

ustice Jude Onwuegbuzie of the Federal High Court, FCT sitting in Apo, Abuja on Thursday, January 23, 2025 granted the prayers of the Economic and Financial Crimes Commission, EFCC to amend charges brought against a former Minister of Power, Olu Agunloye and make him take his plea.

Agunloye is standing trial by the EFCC on seven-count charges, bordering on official corruption and fraudulent award of Mambilla Power Project contract to the tune of \$6billion (Six Billion United States Dollars).

Earlier on July 1 2024, Prosecution Counsel, Abba Mohammed, SAN, drew the attention of the court to the amended charge, urging the court to accept same and cause the defendant to take his plea, relying on the provision of Section 216 and 217 of the Administration of Criminal Justice Act, 2015.

However, defense counsel, Adeola Adedipe, SAN objected to the plea arguing that the leave of the court must be formally sought and obtained before the EFCC can amend its charge.

Responding, the court

directed parties to furnish the court with authorities in support of the argument canvassed to which the EFCC made reference to the Court of Appeal's decision in Bovoa vFRN & Anor (2017)

During Thursday's ruling, the judge held that amendment was not intended to overreach the defendant and cause injustice to him and that a court may permit an alteration or amendment to a charge or framing of a new charge at any time before judgment is pronounced.

"In the court`s final decision, the arguments of the learned counsel to the defendant are hereby discountenanced and therefore hold that the application is liable to succeed accordingly, I so hold, subsequently the appli-cation is hereby granted as prayed on the face of the motion paper and the defendant is hereby ordered to take his plea on the altered or amended charge, this is the ruling of the court".

Justice Onwuegbuzie adjourned the matter to February 3, 2025 for the defendant to take his plea.

FCCPC Insists Telecom Tariff Increase Must Be Commiserate To Service Improvement

his marks a significant turnaround from the pre-tax loss of N8.2 billion in the same quarter of the previous year and is the first quarterly profit since September 2023, when the company posted a profit of N3.8 billion.

The profit boost follows Tolaram Group's takeover of operations from Diageo in June 2024. Within six months, the company recorded its first quarterly operating profit. The secondquarter profit increased halfyear pre-tax profits to about N4.1 billion, marking the first half-year profit since December 2022.

Surge in Revenue Boosts Margins: Guinness Nigeria Plc reported revenue of N259.6 billion for FY 2024, representing an impressive increase of 82.06% compared to FY 2023. Domestic sales accounted for 98.5% of total revenue, while export sales contributed the remaining 1.5%. Despite strong revenue growth, the cost of sales surged by 107.54% year-on-year, rising from N96.6 billion in the previous year to N200.5 billion

However, the company recorded a gross profit increase of 28.45% year-onFY 2023. Marketing and distribution expenses also increased significantly, rising by 33.00% to N31.6 billion from N23.7 billion in the prior year.

With rising operational expenses, operating profit declined to N11.2 billion, down from N16.3 billion reported in the previous

Analysts observed that the primary driver of Guinness Nigeria's profitability was a surge in topline revenue, which hit a record N133.7 billion this quarter—the highest ever recorded by the company. The revenue surge helped mitigate cost pressures,

Guinness reported an operating loss of N6.8 billion at the end of September 2024, its first quarter of the current financial year. Operating profit margins, however, rebounded to 13.2%—the highest since March 2022, when margins stoodataround 18.5

Meanwhile, net finance charges, which had been a major driver of losses in recent years, swung to a net gain this quarter. Although finance expenses more than doubled to N59.5 billion in the quarter under review, this was offset by a surge in finance income totaling N63.9 billion.

This turnaround was pri-

marily driven by gains from the remeasurement of foreign currency balances, which accounted for 99.51% of the finance income The swing in profitability is seen as a significant boost for the new owners of Guinness Nigeria Plc, as they work to revitalize one of Nigeria's largest brewers.

Tolaram Group, which acquired Guinness in June 2024, has reported its first operating profit for the company in less than six months under its management. It is understood that Guinness Nigeria is likely to be delisted from the Nigerian Exchange as the new owners move forward with a mandatory takeover of the company's shares from minority shareholders.

Oando Secures Block KON 13 Operatorship In Angola

ando PLC has announced that its subsidiary, Oando Energy Resources (OER), has been appointed as the operator of Block KON 13, located in Angola's Onshore Kwanza Basin.

This achievement comes on the heels of Oando's successful \$783 million acquisition of the Nigerian Agip Oil Company (NAOC) from Italian firm Eni, covering asset costs and reimbursements.

OER secured the operatorship of Block KON 13 after participating in a competitive bidding process organized by the Angolan National Agency for Petroleum, Gas, and Biofuels (ANPG).

The block, situated in the resource-rich Kwanza Onshore Basin, boasts significant pre-salt and post-salt formations, with an esti-mated potential of 770 to 1,100 million barrels of oil. It also features two exploration wells that have already been drilled to a depth of 3,000 meters, revealing the presence of oil and gas at various

As the block's operator, OER will lead development efforts, holding a 45% stake, while Effimax and Sonangol will serve as co-venturers with 30% and 15% interests, respectively.

CBN Projects 4.1% Economic Growth in 2025

he Central Bank of Nigeria (CBN) has forecast a 4.1% economic growth for 2025, along with a decrease in inflation and an increase in foreignexchange innow.

CBN Governor, Mr. Olayemi Cardoso, shared these projections during the launch of the Nigeria Economic Summit Group 2025 Macroeconomic Outlook. He noted that foreign exchange market reforms in 2025 resulted in \$6 billion in foreign capita

The Federal Government has defended its projection of a decline in the inflation rate to 15% this year, stating that the projection is based on reality and data. The NESG has recommended measures to achieve economic stability in 2025 and a 5.5% economic growth rate.

The World Bank has urged the Federal Government to increase the number of beneficiaries of its social intervention programs to reduce the cost of reforms on the poor and vulnerable Nige-

Cardoso stated that key economic indicators suggest a positive outlook for 2025, ith GDP growth projected torise to 4.17% from 3.36% in 2024. This growth is anchored on sustained government reforms, stable crude oil prices, and improvements in domestic oil production. Increased refining capacity, driven by the Dangote refinery and the revitalization of the Port Harcourt and Warri refineries, will significantly enhance economic activity. A stable exchange rate will also play a crucial role in maintaining this positive trajectory.

Domestic inflation is projected to decline in 2025 as the impact of economic reforms begins to take hold. Achieving overall objectives requires effective collaboration between monetary and nomic resilience. fiscal authorities alongside private sector participation.

The current account surplus is expected to be sustained in 2025 due to strong export performance and cardinate in the current account sufficient exchange finlow, Cardoso said: "Our achievements with these reforms have been encouraging and steady diaspora remittances. Crude oil prices are expected the long term. Appeal Court Upholds Death Sentence Of Adedoyin Over Murder Of OAU Student

he court of appeal in Akure, Ondo state, has upheld the death sentence of Rahman Adedoyin, the owner of Hilton Hotel in Ile-Ife, Osun state, for the murder of Timothy Adegoke, a postgraduate student at Obafemi Awolowo University (OAU).

Adedoyin was sentenced to death by hanging in May 2023 by the Osun state high court after being found guilty of the 2021 murder.

Oyebola Ojo, the trial judge, also convicted two others in connection with the

The court ordered the forfeiture of the hotel and a Hilux bus used to transport Adegoke's body to a dumpingsite.

In November 2021, Adegoke traveled from Abuja to Moro, Osun state, to sit for an exam at OAU's distance learning centre.

He checked into Hilton Hotel but was reported missing two days later. His body was later discovered, prompting investigations that linked his death to Adedoyin and others.

Displeased by the judgment of the high court, Adedoyin approached the appeal court to dismiss the sentence and conviction.

Kehinde Eleja, counsel to Adedoyin, argued that neither the evidence nor the witnesses proved Adedoyin's involvement in the murder

On Thursday, a three-member panel led by Olufemi Akeju upheld the conviction and death sentence of the hotelier, affirming the high court's decision.

The court, however, overturned the earlier order requiring Adedoyin to forfeit his hotel and fund the education of Adegoke's children.

EFCC Arraigns Five For Alleged Tampering With Forfeited Property in Lagos

he Lagos Zonal Directorate of the Eco-nomic and Financial Crimes Commission, EFCC, recently, arraigned Benjamin Okoye, Moughalu David Arinze, Okey Okeke, Ekene Mgbeokwere and Eboh Thaddeus on a onecount charge bordering on alleged tampering with a forfeited property before Justice A.O.Owoeye of the Federal High Court sitting in Ikoyi,

The count reads: "That you, Ilongwo Angela (NOW AT LARGE), Benjamin Okoye, Moughalu David Arinze, Okey Ökeke, Ekene Mgbeokwere, Eboh Thaddeus, sometime in July, 2024 in Lagos State, within the jurisdiction of this Honourable Court, without due authorization dealt, with the property of Obinna Ezenwaka situate and located at Plot 165C, Block 12, Amuwo Odofin, Ajayi Street, Diamond Estate, Amuwo Odofin, Lagos, subject of interim forfeiture to the Federal Government of Nigeria, and you thereby committed an offence contrary to and punishable under Section 32(1) of the Economic and Financial Crimes Commission (Establishment) Act, 2004.

The defendants pleaded "not guilty" to the charge preferred against them.

In view of their pleas, the prosecution counsel, Hannatu .U. KofarNaisa, informed the court of the presence of a witness and that he was ready to proceed with the trial.

Counsel to the first to fourth defendants, M.C. Odo informed the court of pending bail applications for the defendants and also prayed the court to move the same. Counsel to the fifth defendant, N. Chukwuemeka, informed the court of the existing bail previously granted to the defendant.

Odo further prayed the court to admit the defendants to bail, adding that they had been in prison custody for some time. However, Kofar Naisa, in response, informed the court that she had not received the bail applications being moved by the counsel to the first to fourth defendants and that it was not before the court.

The court confirmed it was not on its record.

Thereafter, the prosecution counsel called on Abubarkar Mohammed, an operative of the EFCC, to review the facts of the case. Mohammed told the court that he works as the custodian of assets in interim or final forfeiture with the

When asked by the prosecution counsel if he knew the defendants, he answered in the affirmative. According to him, "I met them during the inspection of Plot 165c, Block 12, Diamond Estate, Amuwo Odofin, Lagos State.

'The EFCC had obtained an interim order of the property. The Proceeds of Crime Månagement Unit that takes care of forfeited assets went to mark the property, with the EFCC written on it.

'On July 22, 2024, I led a team to inspect the property and met the defendants there. I informed them that the property had been forfeited in the interim and also asked them to leave."

Continuing, he said: "

After listening to both par- They left after much hassle and the house was put under lock and key.

"Unfortunately, on July 29, 2024, while conducting routine research, I found out that they had broken the padlock and were still living in the property." He further told the court that the defendants were subsequently arrested for tampering with the forfeited assets.

Mohammed, thereafter. identified the interim forfeiture order secured by the EFCC on October 6, 2017, in respect of the property.

Counsel to the prosecution sought to tender the interim order as an exhibit and it was admitted and marked as exhibit A. When asked to give further testimony about the property, he said there was an order of notification from the Lagos State High Court on the final forfeiture of the property.

Kofar Naisa asked for an adjournment to enable her to bring documents before the court.

Justice Owoeye adjourned till February 14, 2025, for continuation of the

Court Declares Lakurawa Sect Terrorist Group

Federal High Court in Abuja has officially **L**proscribed the Lakurawa sect, declaring it a terrorist organization and extending the ban to similar groups across Nigeria, with a specific focus on the North West and North Central

Justice James Omotosho, in his ruling on the ex-parte originating summons submitted by Justice, Lateef Fagbemi, SAN, the Attorney-General of the Federation and Minister of Justice on Thursday in Abuja.

According to the judge, "It is hereby ordered as follows:An order is issued declaring the activities of the Lakurawa sect and similar groups in any part of Nigeria, particularly in the North West and North Central regions, as acts of terrorism and illegality.'

"That an order is hereby made proscribing the existence of the Lakurawa and other similar groups in any

the North West and North Central Regions of Nigeria either in groups or as Individuals by whatsoever names they are called and publishing same in the Official Gazette and two (2) National Dailies.

"That an order is hereby made proscribing any person or group of persons from participating in any manner whatsoever in any form of activities evolving or concerning the prosecution of the collective intention or otherwise of the Lakurawa underany other name or platform however called or described.

"That an order is hereby made proscribing ali other groups in Nigeria by whatever name called with similar objectives as the Lakurawa which Include but not limited to banditry, kidnapping for ransom, kidnapping for marriage, mass abduction of school children and other citizens, cattle rustling,,enslavement, impris- make the declarations.

In the ex-parte applicamarked FHC/ABJ/CS/41/2025, the Attorney General of the Federation (AGF) sought four orders, all of which were granted by the court. The motion, dated January 13 and filed on January 14, was moved by David Kaswe, an Assistant Director at the Federal Ministry of Justice, on behalf of the Director of Public Prosecutions of the Federation (PPF), M.B. Abubakar.

The affidavit supporting the originating summons was sworn by Michael Akawu, a litigation officer in the Department of Public Prosecutions, who stated that he had obtained the consent of the PPF Director to

> Akawu noted that the activities of the Lakurawa sect/group posed a serious threat to national security, public peace, and order in Nigeria. Based on these grounds, he expressed his belief that the group met the criteria for proscription under the Terrorism (Prevention and Prohibition) Act. He concluded that proscribing the Lakurawa sect/group would serve the best interest of justice, peace, and national security in the Federal Republic of Nigeria.

Pirates Drove A Lot Of Foreign Music Recording Companies Out Of Nigeria - Stella Monye

Stella Monye, known as the Samba Queen is back to the industry that gave her fame after more than two decades hiatus. Her long absence in the industry was as a result of her son's accident. She narrates her experience and how this affected her music career Enjoy this interview she had with Sam Orji

Vu have been outside the music industry for a long time, how are you adjusting to the new trend in the sector now?

In the first place, my long absence was due to my sons accident which became so cumbersome because we have to travel from hospital to hospital and so, I really did not have time to pursue my career for almost two decades that I focused on my son's treatment. Its not as if its over, its just that I told myself, if you dont go back to work; it will be even more difficult to pay his bills because his medical procedure is systematic and its being done in America. I just told myself, you have to go back to work and combine the two. I gave it time and I have gotten to that point where I can say okay; while its still going on, I can still work and cushion the effect of raising money for his treatment.

How has it been carrying the burden of your sons treatment for this long and where has help come from sofar?

I will answer the first question you asked on how I am adjusting back into the business afterso many years.

I know its a generational shift from what we did and what these new generations are doing. Theres no competition. I am not competing with anyone because I believe that whatever I am doing now, I have just moved a bit higher. I have gone beyond singing about mundane things and my songs are inspirational songs based on experience, so I have to sing about positive things that can inspire people. Most of the things you will be hearing from me are positive and inspirational songs and it does not mean that all these while, i have not been singing inspirational songs.

Concerning my son, I have gone through a lot of emotional torture looking at him knowing that when he is in pain, I am in pain as well; knowing that this thing happened when I left him at home for national assignment. I feel guilt because if I had taken him along or had stayed with him, it would not have happened. I have even survived heart attack during this process because I also have my own underlying medical conditions. I am diabetic, I have BP and I am managing everything at the same time. Sometimes I call myself a cat with 13 lives. Financially, its cumbersome, emotionally its stressful and physically its demanding. Now that I have to combine my job with it, I have to look forward to tougher days ahead.

You were on national assignment when this accident happened, was there at a point government, or PMAN or your colleagues came in to support financially?

At the initial time when this happened I remember when we came back from Abuja, it was difficult because the General Hospital then did not do a good job on the surgery they did on him and thats was the genesis of the problem. That was when we started moving him from one hospital to another and my colleagues came out and like I said, at every point theres been like little support from here and there. They marched on the road with me to raise funds and at that time, we raised about N1m which did not go anywhere because each hospital we went to demanded much more than that because it was very complicated and complex surgery. I get help from here today, tomorrow I dont get help; its just being like that.

Whats the state of his health presently, I believe he is in the final stage now?

I pray so because a lot of things happened when we got to America, we had already visited India and Tiglish before we ended up in America all based on recommendations. When we ended up in America, they said they have not seen this kind of thing before because all the surgeries they did have really made things worse. They have really damaged a lot of his organs and there were a lot of technical things they have to perform on him to get him to where he is now. Like I said, he doesnt still have clean bill of health, they are still doing semantic treatment in that when they do one surgery for him, we have to wait for him to heal maybe like six months before we are back on the next one.

Maybe today they are working on his bladder; next time his intestine, or kidney. We are still working and praying that soon they will give him a clean bill of health but funding has been a very difficult part.

In totally, what did the doctors say is actually the problem with your

What happened is that when he had the accident, it was just one major problem and this now festered to other problems. They do this surgery, theres no success, they will say his bladder is not growing, we have to expand his bladder and something happens, they will say it has kicked his kidney, each time theres always a major organ involved, until everything becomes settled and they will give him clean bill of health.

I understand you are working on new album 'Iyaanu', how far have you gone?

I have already completed the 'Iyaanu' album and I was going to set things in motion but He prepared me,' took over because it came from another persons effort and they were ready for whatever it takes to push it out.

Your new song 'He prepared me,' is it out, what inspired the song?

Its a song written by a song company in America called Far Cry. It was inspired by some of the experiences I have gone through which inspired them to write the song for me. For a long time, I wanted to do the song but I found out that I was not mentally ready for it. However, I told myself that if I dont go back

to work, I will continue to pay for that experience.

So, I went to the studio; I did the song and it came out on September 31.

Is it a gospelsong?

No. Its an inspirational song.

Are you going to include the song He prepared me' in the album?

Its a new terrain for me and I will be doing a couple of songs with Far Cry Songs thats the name of the song company. They write songs for artistes. I will be doing a couple of songs with them and you know how these things work, its not like in our time when you record an album and you will have like 12 songs to have a complete album.

Now, by the time I do all the singles, it will be ready for album compilation which is how it works now, do singles and compile them and it becomes an album, unlike during our days when you have to suffer and include15 songs in an album and then one becomes a hit

I started writing songs that I could use for my stage drama and then I wrote Oko mi ye', somebody heard the song and said, 'this one is good; you can make a record out of this. I said I could try and that was how I took my tape to the record company EMI, I dropped it there and never got back to them or asked. So, one day a message came to my fathers house that my demonstration tape was no 1 at the panel and they said I should come for my contract. I was surprised, I didnt take the whole thing serious, I went to EMI and the rest is now history. I recorded an album and it became a hit.

Why would a student write that song, Oko mi ye' (my husband please) when you are not married?

It was inspired by my mum; she endured because she wanted to be with her children. She was really that kind of African woman who told herself that she was not going anywhere even if she has to die looking after her kids because my father was polygamous in nature. My father married more women after my mother, who was the first wife and it was really a battle. So, I have to do a song because of my mum.

How did you get the name, 'Samba Queen'?

I was not the one that gave myself the Samba Queen; it was the media, when I did Arigo Samba. After Arigo Samba which is very percussionist in style and Samba means percussion, like konga that they play in Brazil. Because of the percussion background, the media named me the Samba queen, from then on I became the Samba queen.

When you travelled to the Caribbean during one of your tours, they tagged you the bombshell. What really happened?

Clash Over Nigeria's Oil Future: Dangote Refinery Takes on NMDPRA in ? 100BN Legal Showdown

In a significant legal confrontation within Nigeria's oil industry, Dangote Petroleum Refinery and Petrochemicals FZE has initiated a? 100 billion lawsuit against the Nigerian Midstream and Downstream Petroleum Regulatory Authority (NMDPRA), the Nigerian National Petroleum Corporation Limited (NNPCL), and several prominent oil marketing companies.

The case, filed in September 2024, centers on the issuance of petroleum import licenses, raising critical questions about regulatory compliance, market dynamics, and the future of Nigeria's oil sector.

In the Beginning

The dispute traces back to Dangote Refinery's contention that NMDPRA has been unlawfully granting import licenses to NNPCL and five other oil marketing firms: AYM Shafa Limited, A.A. Rano Limited, T. Time Petroleum Limited, 2015 Petroleum Limited, and Matrix Petroleum Services Limited

Dangote Refinery argues that these licenses were issued in violation of Sections 317(8) and (9) of the Petroleum Industry Act (PIA), which stipulate that such licenses should only be granted in situations where there is a proven shortfall in domestic petroleum products. The refinery asserts that the continued issuance of these licenses undermines its operations and the broader objectives of the PIA.

In the suit, marked FHC/ABJ/CS/1324/2024 and filed on September 6, 2024,

Dangote Refinery seeks several reliefs. A declaration that the import licenses issued by NMDPRA to NNPCL and the five other companies are null and void, as they contravene the provisions of the PIA.

Damages: A demand for ? 100 billion in damages against NMDPRA for the alleged unlawful issuance of import licenses, which Dangote Refinery claims has caused significant financial harm and operational challenges.

Injunction: A court order restraining NMDPRA from further issuing import licenses under the disputed circumstances, to prevent future violations and protect the refinery's interests.

NMDPRA's Defense: In response to the allegations, NMDPRA has defended its actions by highlighting the current state of domestic petroleum production. The authority contends that Nigeria's existing refining capacity is insufficient to meet the nation's daily petroleum product demands.

As a result, to bridge the supply gap and ensure energy security, NMDPRA has been issuing import licenses to reputable companies with proven track records in international petroleum trading. Idris Musa, a senior regulatory officer at NMDPRA, emphasized: "The agency's actions are in compliance with Section 317(9) of the PIA, which allows for the issuance of import licenses to address product shortfalls." Musa further argued: "Relying solely on domestic production, especially during the early stages of Dangote Refinery's operations, could lead to monopolistic practices and jeopardize the nation's energy security.

Current Status of the Case As of January 2025, the legal proceedings are ongoing. A recent hearing scheduled at the Federal High Court in Abuja was adjourned to January 30, 2025, due to procedural delays. Specifically, Dangote Refinery's legal team had not completed the necessary service of amended originating summons on the defendants,

The ? 100 billion lawsuit filed by Dangote Refinery against NMDPRA, NNPCL, and other oil marketing companies represents a pivotal moment in Nigeria's oil industry. The case encapsulates the tensions between regulatory frameworks and market realities, domestic production aspirations and import dependencies, as well as competition and monopoly. 

12 Years Of Agony: Abdullahi Iliya's Struggle For Survival With Untreated Burn Wounds And Tragic Losses

Abdullahi Iliya is above 20 years old and has been nursing open wounds he sustained as a result of burns in his two legs. He has been battling with the wounds for 12 years without proper treatment and the condition of his legs are getting deteriorated, limiting his chances of survival. To worsen his condition, his parents both died few months after the incident, leaving him stranded without a caregiver.

In this interview with our correspondent *Samuel Luka*, Abdullahi narrates how he has been battling with life in such a serious health challenge. Excerpts:

buja Post: Tell us your name, address and age

Abdullahi: My name is Abdullahi Iliya and I live in Wuntin Dada Community, Jos Road, Bauchistate. Iam above 20 years.

Abuja Post: What happened to your legs? I can see wounds all over

Abdullahi: I was caught up in a fire incident which broke out in one filling station along Jos Road, Bauchi about 12 years ago. I have been battling with this wounds since then up to this day that I am talking to you and the little assistance I used to get from some people is no longer there because the treatment has taken a very long time and I lack the money to go for proper treatment. As a result of this problem I couldn't continue in school since the incident happened. My life is been wasted and my hope for better living is crippled due to this lingering health challenge.

Abuja Post: what are your parentsdoing about it?

Abdullahi: My parents have died. When the accident occurred, I was rushes to the hospital where I was given some first aid, I was administered a drip, we couldn't continue with the treatment in the hospital and was taken to herbalist by my caregivers because they were aggrieved that no Doctor came to check on me. So they took me away in anger. My father and mother died about a month after the incident. I was left at the mercy of neighbors who have tried their best by helping with what to eat. As it is now, I live alone in a very small room with nobody to look after me, even to feed or cloth is a big challenge to me. The little assistance I used to get from some people is no longer there because the treatment has been prolonged.

Abuja Post: What happened to your educational pursuit after the incident?

Abdullahi: This thing happened to me while I was still in JSS three, we were about to sit for junior WAEC but I couldn't make it because of the condition I found myself. I couldn't continue in school since the incident happened, I didn't anticipate that the wounds will continue up to date, I am afraid that my life is wasting away and hope dashed due to this lingering health challenge confronting me. My parents have died, living me with no one to take care of me. I rely on well meaning people within the community who often assist me with food, I don't have the health to go out and hustle for

Abuja Post: How have you been managing the wounds?

Abdullahi: That's how I live with it, any time I am given money by a good Samaritan, I rush to chemist to buy some pain killers and other medicines. Of recent, there was only one person called Alassaini who used to help me with money to buy drugs but now he has a lot of burden on him.

Abuja Post: How did the fire incident occurred?

Abdullahi: One fateful day, we were doing some menial work in one filling station when someone made a mistake that caused fire incident which affected us, that was in 2013. When the incident happened, we were rushed to specialist hospital here in Bauchi and we were received at the emer-



gency section where they administered drip on me, then we had no issue with money for the treatment but my caregivers were upset that no Doctor cared to check on me, so they decided to take me to herbalist for further treatment. After the herbalist used some herbs on me, I got relieved, but the wounds failed to heal after some time. They took me to different herbalists but to no effect. I would have love that they take me back to hospital now, but honestly speaking, since my parents have died and with no relatives who are financially sound to shoulder the expenses, I have no option than to continue

Abuja Post: How are you coping withlifenow?

Abdullahi: For me, life is terrible considering my present condition, I have nothing but always relying on what comes from God through good Samaritans, I know that the problem is taking me this long because of lack of adequate treatment, and I am sure that if properly treated, it will be healed and I will bounce back to good health to achieve my life dreams.

Abuja Post: Do you have any plea or appeal to make?

Abdullahi: I want to plead with the Bauchi state government or well-meaning Nigerians to help me with the resources to go back to the hospital in order to have the wound properly treated. Let me have a renewal of hope by getting sponsors of my treatment because I don't have anybody close to me that can help me out, even to get food to eat is very hard. I can be reached through this medium.

Things happening now never happened in our time, nothing like record companies, social media was not there. They practically own their own labels now and get all their money online, so they're making money because the pirates cannot go online. CD is phasing out because people don't use it anymore and nothing for pirates to lay hands on, so this generation is in a better positioned now. It's a great development and it depends on what you listen to. There's a particular song from Buju and I hear a lot of great songs

from Buju, for me, I choose who to listen to because that's who I want to listen to

Tell us any current artiste you will like to work with especially females

The first person that came to my mind is Tiwa Savage, I could do my stuff with her and she would give a good interpretation. She has her own style of singing which I love very much and I know that anything she handles, she does that in her own unique way. I was working on it but somewhere along the line we lost touch and my son's accident became a major distraction, I couldn't go on with it, but if the opportunity comes, I will love to do collaboration with some of them including the male.

You have not tried your hands on full time acting in movies

I acted at some point. I acted in Caravan of Life, which was an NTA TV series and most of the acting was at the earliest part of my career. I did some Nigerian movies with the NTA. I did Magun, not long ago, I did Agbode Meje, (Cross road), a Yoruba movie

When I went into music, I didn't have the full time to go into acting. I love acting and I know I can act. I am really considering it, to see if I can go into full time acting but I still believe my music may not give me the opportunity.
