The Power Equation: Who Really Runs Nigeria?

n Nigeria, the ques-tion of who truly holds the reins of power goes far beyond the occupants of elected offices. While the President, governors, and lawmakers may serve as the public face of governance, the real power equation in Africa's most populous nation is far more complex, layered, and, at times, opaque. It is a web spun from political alliances, economic interests, ethnic considerations, religious influences, and deep-rooted patronage networks.

democratic republic with power theoretically vested in the people, who exercise their will through elected representatives. The Presi-dent of Nigeria wields significant executive power, controls the military, appoints ministers, and drives national policy. Governors also enjoy sweeping powers at the state level. But elections in Nigeria are often marred by allegations of vote-buying, rigging, and voter suppression, raising questions about the legitimacy of those who emerge

These influential figures—former presidents, ex-governors, and wealthy elites—use their resources and networks to install loyand networks to install loy-alists into office, expecting unwavering allegiance in return. The godfather-godson relationship has shaped political outcomes across Nigeria's states, from Lagos to Rivers, and from Kano to Anambra from Kano to Anambra.

Bola Tinubu, before becoming President, was famously known as the "Lion of Bourdillon," a kingmaker whose influence in Southwest Nigeria's politics was undeni-

Power in Nigeria is also tightly interwoven with control over the security apparatus. The military, police, and intelligence agencies are not only tools of state-craft but also instruments of political leverage. Those who command loyalty from security chiefs often wield significant power behind the scenes. In times of crisis, security forces have been known to tilt the balance in favor of particular factions or regimes.

The term "cabal" has

Though difficult to define precisely, the cabal is believed to comprise a mix of powerful businesspeople, family members of leaders, and close political allies. telecommunications sectors—frequently influence government policy through lobbying, campaign fund-ing, and strategic partner-ships. Multinational corporations and foreign govern-ments, particularly China, the United States, and the United Kingdom, also wield soft power through investment, aid, and diplo-

Ironically, the Nigerian populace—the supposed source of all democratic power—often finds itself sidelined. Mass protests like #EndSARS show that the people can challenge the status quo, yet systemic barriers, poverty, and political apathy often hinder sus-tained civic engagement. Still, in an age of social media and youth mobilization, the power of the peo-ple may be the sleeping giant that could yet reshape Nigeria's future.

Speaking to The Abuja Post on this issue, Paul Amodu, a political analyst, commentator, and governance consultant based in Abuja. said, "as someone who has observed Nigeria's political landscape for over two decades, I can tell you with certainty that the question, "Who really runs Nigeria?" is not as rhetorical as many assume. It's one of the most important inquiries of our time, and the answer reveals just how much of our national destiny is steered outside the ballot box.'

According to him, "in theory, power lies with the people. In reality, power lies in the hands of a deeply entrenched elite—an inter-locking group of political godfathers, security operatives, bureaucrats, and economic interests who operate in shadows and boardrooms, not necessarily in the chambers of the National Assembly."

"Every four years, Nigerians head to the polls with high hopes. Yet, what follows is often a cycle of disappointment. Why? Because elections in Nigeria are rarely about competence or ideas. They're about loyalty to political structures, access to finan-cial war chests, and endorsements from key powerbrokers. The real decisions—on who gets nominated, which region produces the next president, or who controls the

economic levers—are made long before the first vote is cast." He added.

He stressed that, "Let's talk about the so-called "cabal"—a term many brush aside as conspiracy theory, but which is all too real for those of us who follow governance closely. These are not officeholders in the traditional sense. These are individuals with direct access to power: relatives, loyal aides, former military generals, and businessmen who never appear in official

statements but whose fingerprints are on every major policy shift."

He further stated that, "during President Buhari's tenure, the cabal was said to wield significant power, sometimes even sidelining the Vice President and ministers. That's not new—it's been a pattern since the days of military rule. Even under democracy, Nigeria's real power often rests with those who control the president's ears, not necessarily those in the cabinet."

"Another pillar in the power structure is Nigeria's security apparatus. The military may no longer be in power officially, but make no mistake—they've not gone anywhere. Former generals and serving intelligence chiefs remain central to national decision-making, especially on matters of security, national unity, and elections. When power is contested or in flux, these institutions often serve as kingmakers or enforcers.'

"Ethnicity and religion play a subtle yet powerful role. Nigeria's unwritten rules—like zoning and rotational presidency—are con-cessions to our deeply divided national identity. While intended to promote inclusivity, these arrange-ments are often exploited by elite actors who use them to negotiate power, not necessarily to foster unity or development."

"We also can't ignore the power of wealth. From oil barons to telecom magnates, Nigeria's billionaire class funds elections, influences policies, and often dictates economic direction. Sometimes, these interests override the will of the people, especially in matters like subsidy reforms, deregulation, or trade policies." He noted.

Here's the most tragic part, he continued, "the ordinary Nigerian is powerful in theory but power-less in practice. Protests like #EndSARS, voter turnout, and social media activism show signs of awakening, but structural suppression—through poverty, fear, and disinformation-often mutes the people's voice. Until we address this, real power will continue to reside with those who were never

"So, who runs Nigeria?
My answer: a coalition of the power fulfew—politicians, businessmen, godfathers, and security chiefs—who are often more accountable to one more accountable to one another than to the Nigerian people. Democracy exists here, but it's filtered through a patronage system so thick that true representation is rare. If we want to change the power equation, we must strengthen institutions, demand transparency, and empower citizens—not just to vote, but to hold the system accountable every single day." He noted.

according to him, "as a student of history and a passionate observer of the Nigerian socio-political terrain, I say without hesitation: we are in a capture state—where public institutions have been hijacked by private interests. And until we come to terms with this, we will keep mistaking figureheads for power hold-

"We often talk about the

many cases, those elected are mere frontmen for deeper, more entrenched interests. Some cannot even appoint their own aides without consulting their political benefactors. Others operate under strict "guidelines" dictated by the same men who sponsored their campaigns and manipulated their emergence." He added.

Further, he disclosed that, "the Nigerian political godfather is more than just a mentor—he is the puppet master. He decides who gets tickets, who gets contracts, and who gets protected. These godfathers don't contest elections because they don't need to. Their power lies in their control of politi-cal structures, party machineries, and, in some cases, electoral umpires."

Look around: in many states, former governors still control the political direc-tion long after leaving office. In Abuja, there are men you will never see on TV who have more influence than half the cabinet.

We must also speak plainly about the so-called President, the governors, the senators, as if they are Cabal. Whether it is during Obasanjo's time, Jonathan's

the true power holders. But in Nigeria, office does not always equal power. In inner circle that operates behind closed doors. They determine ministerial appointments, major policy directions, and, crucially, who gets to be in or out of favour." He noted.

Continuing, he pointed out that, "these are not conspiracy theories; they are confirmed by insiders, former aides, and the political elite themselves who whisper it when power slips from their hands.

"Our economy is not immune from this power game either. The captains of industry—especially those with oil blocks, customs waivers, and import monopolies—often dictate economic policy. Government officials don't challenge them because them lenge them because they fund campaigns, own media houses, and sit at the table with international partners. In some cases, they even write the policies themselves through proxy consultants."

"Nigerians are powerful only during election season, when politicians need their numbers and their noise. After that, the people are discarded—left to beg for electricity, fight over fuel, and queue for palliatives. But

this is not accidental. A hungry and divided people are easier to control. That is why poverty persists. That is why education is underfunded. That is why dissent is crushed."

"If we truly want to reclaim Nigeria, we must stop romanticizing the system. We must educate ourselves on how power works—not how it should work, but how it actually works. We need civic education at every level. We need to organize, not just protest. We need to demand transparency, not just complain online. And most of all, we need to understand that no godfather is greater than the collective will of an awak $ened\,people."\,He\,noted.$

So, who really runs Nigeria? The answer is not straightforward. Power is dispersed among formal institutions, informal networks, and shadowy influences. Until systemic ences. Until systemic reforms enhance transparency, accountability, and citizen participation, the power equation will remain skewed—largely favoring the few at the expense of the

Abuja Raid Attack: 3 NDLEA Officers Sustain Gunshot Injuries, Hospitalized

hree officers of the National Drug Law Enforcement Agency, NDLEA, have been hospitalized for gunshot injuries sustained after they came under attack from some armed men during a raid operation in Jahi area of the Federal Capital Territory, Abuja on gunattack. Thursday night.

The incident occurred when a team of NDLEA operatives acting on intelligence and surveillance

report raided an uncom-pleted building at NNPC area of Jahi where 74 bottles of codeine, 10 litres of codeine syrup, 48grams of tramadol 225mg and 4.9kilograms of skunk, a strain of cannabis, as well as five android phones were recovered.

As the NDLEA team made their way out of the location, they came under

Three of the NDLEA personnel involved in the raid sustained gunshot injuries: one in the rib and two others on their

back and leg.

The wounded officers were initially stabilized at the Police Člinic in Garki Area 1 before they were transferred to the National Hospital Abuja for further medical atten-

Chairman/Chief Executive Officer of NDLEA, Brig Gen Mohamed Buba Marwa (Rtd) expressed appreciation to the staff of the Police Clinic for their prompt support. He also thanked the Chief Medical Director of the National Hospital who

was personally reached by him for overseeing the treatment of the wounded

The NDLEA boss who is in Kano on official engagements also spoke on phone with the injured officers to wish them quick recovery. He assured them that the Agency will deploy every means at its disposal and work in collaboration with other security agencies to fish out those responsible for the attack on them.

NDLEA Recovers 563kg Skunk, Others In Bayelsa Warehouse, Arrests 4

he National Drug Law Enforcement Agency, NDLEA, has recovered no few than 557.2kg of skunk, 5.6kg of methamphetamine and 29.8grams of heroin from a warehouse in Bayelsa.

This is contained in a statement by the NDLEA director, Media and Advocacy, Femi Babafemi in Abuja on Šunday.

Mr Babafemi said that the drugs were intercepted along Major General Isaiah Alllison Street, Opolo, Yenagoa, Bayelsa, adding that four suspects were arrested.

This, he said was when NDLEA operatives raided the premises on Wednesday, April 16.

"The four suspects arrested during the raid include: Kurtis Sarimiye, 46; Roland Prosper, 34; Paul Sarimiye, 45; and Fidelis Ugbesla, 46,"he added.

Meanwhile, a total of 1,100 kilograms of skunk were recovered from a delivery van with the driver, Ismail Abdullahi arrested in Surulere area of Lagos on Thursday, April 17.

Mr Babafemi said that NDLEA operatives in Kaduna on Friday, April 18 raided the hideout of a suspect, Ike Ani, 30, in Zaria, where no fewer than 31,950 pills of tramadol 225mg and diazepam were recovered.

Also, in Kebbi, NDLEA operatives on patrol along Bagudo road on Friday, April 18 intercepted a vehicle loaded with bags of charcoal coming from Malabil, Benin Republic.

"A search of the vehicle led to the recovery of 97kg skunk concealed in the sacks of charcoal.

"Three suspects: Abubakar Ibrahim, 50; Mustapha Aliyu, 32; and Bashar Lawali, 28, were arrested in connection with the seizure.

"In a related development, the NDLEA arrested a 48-year-old, Okafor Marcel with 11.5kg skunk at Abatete, Anambrastate." he said.

Mr Babafemi said that the NDLEA operatives in Oshogbo, Osun state, on Tuesday, April 15 also arrested Ajala Mercy, 27, with 43 litres of skushi, a mixture of black currant, cannabis and opioids.

Tinubu Cannot Solve Nigeria's Worsening Insecurity — Atiku

mid ongoing vio-lence in Benue State and across parts of Nigeria, former Vice President Atiku Abubakar has again sharply criticised President Bola Tinubu, accusing him of being inca-pable of addressing the country's deepening security cri-

In a strongly worded statement posted late Saturday on X (formerly Twitter), Atiku condemned what he described as Tinubu's "dis-turbing indifference" and failure to lead with empathy in the face of national trauma.

The former vice president's remarks come after dozens were killed in fresh attacks on the Logo and Gbagir communities in Ukum Local Government Area of Benue State.

While the country mourns, President Tinubů has remained abroad, prompting Atiku to call into question not only his absence but his administration's overall capacity to respond meaningfully to the

"The Tinubu administration has proven, time and again, to be utterly incapable, wholly incompetent, and completely devoid of any coherent ideas for tackling Nigeria's deepening security crisis," Atiku said.

He added that the view was not his alone, claiming that "a growing consensus" of opposition leaders, security experts, and even some members of the ruling party privately agree with this sentiment.

Leadership, Atiku argued, demands not just action but presence. Drawing comparisons with global leaders, he noted that U.S. President Barack Obama once cut short a diplomatic trip after a mass shooting, and South Africa's President Cyril Ramaphosa returned home during an electricity

Even controversial figures like U.S. Senator Ted Cruz, he said, faced public

backlash for leaving their constituents behind in a moment of crisis.

"In our own history, President Goodluck Jonathan returned from Equatorial Guinea in 2014 following a deadly bomb blast in Abuja. That is the expected minimum in moments of national trauma," Atiku

"Yet President Bola Tinubu, incapable of solving Nigeria's worsening insecurity, chooses instead to gallivant across Europe - governing Nigeria in absentia as iffrom a holiday perch."

Benue State has been a flashpoint of deadly attacks over the years, with communities in the Middle Belt often bearing the brunt of clashes between herders and farmers, banditry, and other forms of organized violence. The latest killings in Logo and Gbagir have reignited national outrage and calls for urgent action.

Despite rising insecurity, the presidency has not issued a detailed public response to the Benue killings as of Sunday morning.

Meanwhile, Atiku insists that Nigerians deserve not just better security, but a president who can be physically and emotionally present in moments of national pain.

"If Tinubu cannot act, the least he can do is show up. If he cannot lead with empathy, he should at least attempt the performance of it. Nigeria is bleeding. Nigerians are dying. The president is nowhere to be found," Atiku wrote.

He extended his condolences to the people and government of Benue State, expressing solidarity and grief while reiterating his commitment to holding the administration accountable.

"An inept administration may not suddenly discover competence. But we will not stop calling it out," he said. "If Tinubu cannot deliver safety and dignity to Nigerians, the very least he can do is pretend to care – regardless of ethnicity, religion, or political affiliation."

Rights Group Sues Nigerian Govt Over Ban Of Eedris Abdulkareem'haAnti-Tinubu Song

he Socio-Economic Rights and Accountability Project (SERAP) has filed a lawsuit against the National Broadcasting Commission (NBC) over what it describes as the "arbitrary and unlawful" ban of Eedris Abdulkareem's politically charged song, Tell Your Papa.

The song, which takes a critical swipe at President Bola Tinubu's economic policies, was recently prohibited

from airing on broadcast stations across Nigeria, with NBC claiming it violated "public decency standards."Nigerian cultural

In response, SERAP is now challenging the ban in a suit marked FHC/L/CS/797/2025, filed at the Federal High Court in

According to the group, the NBC's directive not only suppresses artistic freedom but also violates Nigerians'

constitutional rights to freedom of expression, access to information, and media free-

In a statement signed by SERAP's Deputy Director, Kolawole Oluwadare, the organisation is asking the court to issue an order setting aside NBC's ban as unconstitutional and unlawful.

SERAP also wants the court to grant a perpetual injunction restraining NBC or any government agency from stopping the broadcast



Nigeria Gradually Becoming A National Morgue - Kukah

he Catholic Bishop of Sokoto Diocese, Matthew Hassan Kukah, has expressed deep concern over Nigeria's deteriorating security situation.

In his Easter message delivered on Sunday, Bishop Kukah warned that the country is slowly turning into a vast national morgue due to incessant killings and widespreadviolence.

He lamented the scale of human suffering across the nation, describing the current climate as marked by "a culture of brutality and savagery never witnessed in the history of our dear country."

Kukah used the metaphor of the crucifixion to illustrate the extent of national pain, calling on President Bola Ahmed Tinubu to urgently intervene and rescue citizens from what he termed "this cross of evil."

"Mr. President, we all admit that you neither erected this cross nor initiated our collective crucifix-ion. However, Nigerians have been left bleeding and dangling on this cross of pain and mindless suffering for far toolong," he said.

The Bishop condemned the increasing frequency of kidnappings, killings, and other forms of violent crimes across the country, stating that no household or com-munity remains untouched by the wave of insecurity.

"A dark pall of death hangs languidly from north to south. Every day, innocent citizens are kidnapped and held under the most inhuman conditions. Nigeria is reaching a breaking point," Kukah warned.

He further criticized the

government's approach to economic hardship, particularly the reliance on palliative distributions, which he said erodes the dignity of citizens.

"While we agree that removing fuel subsidies was a necessary decision and acknowledge the availability of more domestic resources, the reality is that farming has become one of the most dangerous occupations in Nigeria for over a decade. Mere palliatives are insufficient. What Nigerians need is sustainable access to food and security," he stated.

Calling for urgent reforms, the Bishop urged President Tinubu to enshrine food security as a fundamental human right.

"Make food security a constitutional right for all citizens. Mr. President, please bring us down from this painful cross of hunger," he

Despite the grim picture, Bishop Kukah encouraged Nigerians to hold on to hope, reminding them of their collective responsibility to drive out the darkness engulfing the nation.

The structural deformities, iniquities, and corruption of our country must not be an excuse to lose hope. We are the light of the world, a city set on a hill. With the light of Christ, we can build a society that reflects the will of our Creator," he said.

He concluded his message with blessings for the nation and a call for renewed faith in the country's poten-

Flood alert: FENRAD advocates for proactive measures to reduce flood risks

igeria is bracing for potential flooding in 2025, withwarnings from the Nigeria Meteorological Agency (NiMet) and the Nigeria Hydrological Services Agency (NIHSA) indicating that many states may be

Over 1,200 communities in 30 states are at high risk of flooding this year.

Foundation for Environmental Rights, Advocacy & Development (FENRAD) has called on the Abia State Government to implement early mitigation and adaptation strategies in response to the Federal Government's alert that 31 states, including Abia, are at high risk of flood-ing in 2024.

FCCPC Seals Shops **Engaged in Deceptive** Rice Rebagging in Utako Market, Abuja

he Federal Competition and Consumer Protection Commission (FCCPC) has sealed several shops in Utako Market, Abuja, after uncovering deceptive practices involving the rebagging of locally produced rice as foreign brands.

The enforcement operation, which took place on Tuesday, April 15, 2025, was prompted by complaints from brand owners and concerned consumers.

The affected shops were found to be rebagging and marketing rice under popular brand names that have been out of circulation for nearly a decade, including Royal Stallion and Mama Gold. The Commission confiscated the counterfeit products and sealed the stores involved in the illicit trade.

Speaking to journalists during the operation, Mrs. Boladale Adeyinka, Director of Surveillance and Investigation at the FCCPC, revealed that the action followed verified reports from brand owners. "We received credible information indicating that certain rice brands, including Royal Stallion, are no longer available in the Nigerian market, she stated.

Mrs. Adeyinka further explained that the persistent demand for foreign rice has created an avenue for unscrupulous traders to deceive consumers by rebagging local rice as imported varieties. "Because of the demand for foreign rice, some market cartels have resorted to rebagging local rice and passing it off as imported. This is a clear case of deception," she said.

The Commission's intervention is part of its broader mandate to protect consumers from misleading and unfair trade practices and to ensure transparency in Nigeria's markets. The FCCPC reiterated its commitment to sustaining surveillance and enforcement activities to safeguard consumer rights and uphold market integrity.

'Nigerian firms recorded 4,388 attacks per week in Q1'

igerian organisations experienced 4,388 attacks per week in the first quarter of 2025, representing a 47 percent increase year-on-year (y-o-y), a cybersecurity platform, Check Point Šoftware, has disclosed in its 'Global Cyber Attack Report' for

In Q1, global tion, with 3,286 weekly 1,884 attacks per week, a 2024. cyberattacks recorded a 47 attacks, reflecting a 39 per- 69 percent y-o-y increase; Otl percent surge, with organisations averaging 1,925 attacks per week. It noted that this spike highlights the growing challenge businesses face in maintaining robust cybersecurity postures amid a constantly evolving threat landscape.

Africa recorded the highest average number of cyberattacks per organisacenty-o-y increase.

Other regions, such as the APAC region, recorded an average of 2,934 attacks, a 38 percent increase; and Latin America recorded a 108 percent increase, reaching 2,640 attacks per organisation per week.

Top African countries featured on the list included South Africa with 69 percent y-o-y increase; Angola with 4,727 attacks per week (a +32 percent rise); and Kenya with 4004 attacks per week on average (a +14 percent increase).

Sector-wise, the educational sector was the hardest hit in Q1 2025, averaging 4,484 attacks per organisation per week, a 73 percent increase from Q1

Other sectors included the government sector with 2,678 attacks per organisation per week, and the telecommunications sector with 2,664 attacks per organisation weekly.

FG Shuts down Enugu Airport for Emergency Repair of Runway

he Federal Government has announced the temporary closure of the Akanu Ibiam International Airport in Enugu, Enugu State, for emergency runway repairs.

Director, Public Affairs and Consumer Protection, Federal Airports Authority of Nigeria (FAAN), Mrs. Obiageli Orah, explained that there was a sudden and significant rupture in the asphalt surface at a critical section of the runway and that was why the federal government decided to shut it down for rehabilitation.

Repair work would take off from April 22, 2025 to May 6, 2025, after which the airport would be reopened for flight operation.

"In compliance with Nigerian civil aviation regulations, the Federal Air-

ports Authority of Nigeria has, therefore, closed the runway during this period. As part of FAAN's commitment to passenger safety and the modernisation of airport facilities, the runway will not be open for landings or takeoffs during the reha-bilitation period," Mrs. Orah said.

The agency therefore appealed to all airport users and stakeholders for their understanding and cooperation during this time, disclosing that flights to the airport would be diverted to nearby airports.

At the weekend, Nigeria's major carrier, Air Peace, announced withdrawal of its operations to the Enugu airport and said it was diverting flights to Asaba airport and would resume service to Enugu when the runway had been repaired and certified.

Money Supply Hits N114.2trn Despite CBN Tightening

espite sustained monetary tightening by the Central Bank of Nigeria (CBN), the country's money supply reached a historic high of N114.2 trillion in March 2025, reflecting continued liquidity growth in the financial system.

According to the latest data released by the CBN, the broad measure of money supply (M3) grew by N3.86 trillion between February and March. This marks a significant curbing inflationary pressions of the liquidity surge.

Benue Valley Bleeds: The Cost of Neglect

In the fertile heart of Nigeria lies the Benue Valley — a region of quiet strength, agricultural abundance, and cultural richness. But today, it stands as a symbol of tragedy, where the silence of neglect has spoken louder than the screams of its people. The cost? Lives lost. Communities destroyed. A future threatened.

Benue State, long known as the nation's "food basket," now reels under a humanitarian crisis that has become too common, too normalized. Villages are attacked in the dead of night. Families are torn apart by violence. Children grow up in Internally Displaced Persons (IDP) camps instead of classrooms. And while the people cry out, what they receive in return is a deafening silence from those in power.

This is not merely a crisis born of conflict — it is a crisis deepened and sustained by neglect.

Year after year, reports of deadly attacks on farming communities are met with condolences and vague promises. Little changes. Perpetrators often go unpunished. Survivors are left to pick up the pieces without adequate support. And the land — once tilled to feed millions — now lies fallow under the shadow of fear.

The Nigerian state has failed

Benue in the most fundamental way: by not protecting the lives and livelihoods of its citizens. Security presence is sporadic, underfunded, and often arrives too late. Resettlement plans for displaced communities remain on paper. And in Abuja, the urgency of the Benue tragedy seems to fade behind the noise of politics and power plays.

Neglect has a price. It shows up in the form of trauma that spans generations. It shows up in the decline of food production, worsening hunger and poverty. It shows up in the erosion of trust in government, and in the rise of communal tensions that threaten the fragile threads holding Nigeria together.

Benue doesn't need pity; it needs protection, policy, and political will. The government must prioritize restoring security in rural areas, ensuring justice for victims, and rebuilding livelihoods. Beyond that, a long-term plan for peace, reconciliation, and sustainable land-use management is essential.

The bleeding in the Benue Valley cannot be allowed to continue. The longer we ignore it, the higher the cost — not just for Benue, but for the entire nation.

The question now is: how much more must the valley bleed before Nigeria truly listens?

Wike Queries Abuja University's Acquisition of 1,000 Hectares of Land, Says It's Unfuturistic

he Minister of the Federal Capital Territory (FCT), Nyesom Wike, has described as unacceptable the acquisition of 1,000 hectares of land by University of Abuja, now known as Yakubu Gowon University.

This was as the minister on Friday officially inaugurated the Utako Farmer's Market, Abuja.

The facility, which is Nigeria's first evergreen solar powered market, was developed on 3,000 square meters of land, consisting of 50 lock up shops, 40 informal stalls and seven warehouses.

On the acquisition of 1,000 hectares of land by the University of Abuja, the minister made the observation yesterday during an inspec-tion of ongoing infrastructure projects such as OSEX and the road leading to the EFCC Academy ahead of activities marking President Bola Ahmed Tinubu's second year in office.

He described the move as unfuturistic, excessive and a hindrance to developmental efforts within the terri-

"I have discovered and

also opened my eyes as to the kind of land that the University of Abuja has acquired. It is not acceptable. You can't deny development, where a university will go and take over 1,000 hectares of land for what purpose? We have been to universities, we have gone around to schools, just the grabbing of land is not the whole thing. It is just for development purposes," Wikesaid.

The minister also lamooned the institution for failing to put the land to productive use, warning any public land left fallow would be repossessed and reassigned.

"If you don't develop it, the government will take it back and give it to those who will. We must stop this idea of acquiring land just for acquisition's sake," he said.

He also questioned the underlying motive of such large-scale land acquisition saying, "Before you know it, they will begin to lease it out to people. It doesn't make sense. What makes a university is not the large expansion of land. What makes a university is the infrastructure, and the quality. It is not about land. You can have 20,000 hectares of land and the university does not have any infrastructure. So, what does it help? We must stop this idea of just acquiring land for acquiring sake. That is not the essence of it. If they give you land, if you develop it, fine. if you don't develop it, the government will take it back and give it to those who want to develop. So that is our position."

Meanwhile, speaking while unveiling the market in Abuja yesterday, the FCT Minister, Wike, stated that the inauguration of the market marks a significant milestone in boosting commercial infrastructure and economic growth within the Federal Capital Territory.

Represented by the Minister of State for FCT, Dr. Mariya Mahmoud, Wike said by investing in such infrastructure, the Bola Tinubu administration has demonstrated its commitment to creating opportuni-ties for economic expansion and improving the quality of life for residents.

Enugu Govt to develop 135.5km standard gauge rail line connecting South-East cities to Onne Port

Government has announced plans to develop a 135.5-kilometre state-owned standard gauge rail line, designed to connect key South-East cities to the Onne Port in Rivers State.

The State Commissioner for Transportation, Dr. Obi Ozor, shared this update during an interview on the Enugu Kwenu Programme aired on Afia TV on Friday, where he provided insights into the state's ongoing transport developments and the potential impact of the proposed rail project.

Dr. Ozor confirmed the completion of a feasibility

He also highlighted that the Enugu Government is collaborating with the Nigerian Railway Corporation and Chinese companies on rail infrastructure, while negotiating with investors for financing.

He emphasized that the rail line aligns with the state's goal of positioning Enugu as a key hub for regional trade and logistics.

The proposed rail line will run from Enugu through Ugwuoba, connecting to Awka and Onitsha in Anambra State. It will extend

The Enugu State study for the Enugu rail net-through parts of Ebonyi via the Amechi Idodo axis, link Umuahia and Owerri through Nkanu West and Isiagu, and terminate at the Onne Port.

"As part of turning Enugu State into a hub, rail is a critical part of that to enable the movement of agro commodities from wherever their sources are to all the way to the port for export and earning of foreign exchange.

We have a lot of wealth locked underneath our soil, such as coal. We need to exploit them to be able to generate a lot of revenue, and rail is critical to it. And that rail is also important to connect all

the South Eastern cities because they have some level of affiliation to Enugu," the commissioner stated.

He added, "The line we are about to build is stateowned. It is a 135.5km standard gauge line that connects Enugu to all major cities in the South East. You are going to see a proper connection to Anambra through Ugwuoba, you are going to see a connection to Ebonyi through the Amechi Idodo axis. And of course, connecting to Umuahia, Abia and Owerri through the line that passes through Nkanu West to Isiagu and going all the way to Onne Port."

that the rail line will serve both passenger and cargo services, improving goods movement and reducing reliance on Lagos ports. He added that it will also ease cargo flow from neighbouring states like Delta, alleviating pressure on Lagos' congested ports.

Uncertainty Surrounds Planned Pro-Wike Rally In Bayelsa Amid Legal Challenges

Six days before the much-publicised rally scheduled for April 26, 2025, in Yenagoa, Bayelsa State, doubts loom over whether the event will take place as planned.

The rally, which is organised by the NEW Associates group, is meant to show support for the Federal Capital Territory Minister, Nyesom Wike, but internal disputes and legal challenges are threatening its success.

The rally, coordinated by a key member of the Peoples Democratic Party (PDP) in Bayelsa, George Turnah, has already been disrupted by divisions among its organisers and a court injunction halting the event.

A High Court in Bayelsa issued an order restraining the organisers from holding the rally, citing con-cerns that it could disrupt the peace in the state.

Amid the legal setbacks, reports have emerged of financial mismanagement within the organising group. According to Comrade Ogedengbe, a key member of the group, there is dissatisfaction over the way funds for the rally are being managed.

According to Vanguard, Ogedengbe revealed that significant contributions had been made by political leaders and federal agencies from the Niger Delta region, but the manner in which the funds are being spent has raised concerns.

'We are not happy with the way the money is being spent. We all know how much people are contributing to it and even leaders of

federal agencies in the region. We have found out that the group was created out of the name of the minister, Nyesom Wike, NEW Associates. My group and others are opting out of the rally, since somebody wants to use others to achieve his own personal political agenda, Ogedengbe stated.

Tensions have been brewing among the organisers, with some accusing others of attempting to monopolize the rally. Disputes reportedly erupted on the group's WhatsApp platform over the dis-bursement of funds, with members calling for transparency.

The quarrel escalated when a former State Chairman of the PDP, who had initially supported the rally, distanced himself from the group after being sidelined in the planning process.

He expressed his anger on the WhatsApp plat-form, saying, "It doesn't work this way. Please forget about me. I don't want to be used and dumped.

In a statement issued by Turnah, he accused infiltrators of undermining the rally's progress and stated that a weeding process had begun within the group.

Complicating matters further, the Yenagoa High Court affirmed Turnah's suspension by the PDP State Working Committee, ruling that his removal from the party's Zonal Secretary position was in line with the party's constitution. This ruling has added another layer of complexity to the already unstable situation within the organising group.

Minor Who Stood Before Peter Obi's Convoy Freed After Months in Kirikiri on Police False Robbery Charge

uadri Yusuf Alabi, the 17-year-old whose act of standing before the convoy of Labour Party presidential candidate Peter Obi during the 2023 general elections elicited the generosity of many Nigerians, has regained his freedom after months of wrongful detenmonths of wrongful detention at the Kirikiri Medium Security Custodial Centre in

On Thursday, 17th April 2025, a Lagos Magistrate's Court sitting in Apapa dis-charged and released Quadri after the Lagos State Director of Public Prosecutions (DPP), Dr. Babajide Martins, found no evidence

against him.

It was gathered that Quadra's legal ordeal began in January when he was abducted near his family home in Amukoko, Ajeromi-Ifelodun Local Government Area by two notorious area boys known in the community as "Lege" and "Baba Waris".

According to his legal counsel, human rights law-yer Inibehe Effiong, the duo had long harassed the teenager out of envy, demanding a portion of donations he had received following his viral encounter with Peter Obidwing the last election Obiduring the last election.

Effiong revealed that the Baale of the community also pressured Quadri's family to

the area boys.

The teenager, who was returning from work at the time of the incident, was dragged to the Amukoko Divisional Police Headquar-ters, popularly known as Pako Police Station.

While the abductors initially accused him of street fighting, the narrative shifted dramatically when the police, on 26th January 2025, arraigned him before a Magistrate and claimed he was involved in an armed robbery.

"In a clear abuse of process, the police joined Quadri with four unknown adults — men he had no prior connection with — and press statement released on Thursday.

The police also falsely declared Quadri's age as 18, concealing his actual age of 17 in what Effiong described as "a deliberate and sinister move to subject him to adult legal processes.

Effiong's legal team only became aware of the case last week after the matter was brought to the public's attention by Ms. Hassana Nurudeen, co-founder of Ray of Hope Prison Outreach, who raised the alarm on social media.

Following swift legal intervention, the case was brought before Magistrate A.O. Olorunfemi, who, after

The Magistrate accordingly discharged and freed the teenager.

Effiong commended the DPP for "standing by the truth," but condemned the actions of the Amukoko Police, calling for urgent disciplinary action against

The legal team is demanding a public apology from the Nigeria Police Force and compensation of N100 million for Quadri's unlawful detention and psychological trauma. Failing this, Effiong warned, legal action will be instituted to seek full redress.

"We demand that the Commissioner of Police, Lagos State Command and the Comman that plague the Nigeria Police Force. There are many other 'Quadris' lan-guishing in cells and prison yards across the country because of unbridled corruption and a broken justice system," Effiong said.



Inside Aso Rock: The Silent Struggles for 2027

From the cool, marbled interiors of Aso Rock to the crowded press rooms in Abuja, there's an unspoken tension—an undercurrent of political maneuvering cloaked in public denials. Though the 2027 general elections seem distant on the calendar, within Nigeria's power circles, the contest has already begun. Not with declarations or rallies, but with whispers, alignments, and subtle plays of influence.

President Bola Ahmed Tinubu, less than two years into his first term, finds his name at the center of both fierce loyalty and quiet skepticism. Officially, he remains focused on policy and reform. Unofficially, insiders say 2027 is already on the agenda—and not just for Tinubu.

"Ican tell you for free, there is no vacancy in Aso Rock come 2027," said Sir Jude Idimogu, a former Lagos State lawmaker and influential APC voice. Sitting behind a large wooden desk in his Lagos office, he leaned forward, eyes fixed. "Those thinking they can unseat the president are simply dreaming. The North had their eight years. It's the South's turn to complete its cycle."

Idimogu's remarks are not isolated. Across APC strongholds, a rallying cry is

forming: consolidate, retain, extend. The logic is simple—Tinubu's administration, they argue, needs a full two terms to complete the reforms it has begun. But behind the façade of unity lies a web of internal recalibrations, ideological disagreements, and growing concerns about the party's direction.

Dr. Salihu Lukman, a founding APC member and former DG of the Progressive Governors Forum, is one of the dissenting voices. "The APC is drifting," he warned in a recent interview. "If we don't return to our foundational principles and allow internal democracy to flourish, we risk defeat in 2027."

His concerns reflect deeper currents within the party—grievances over appointments, regional balancing, and the growing perception that some power blocs are being sidelined. It's a quiet struggle, one that rarely makes headlines but simmers beneath the surface of the administration's every move.

Meanwhile, outside the ruling party, an unusual political dance is unfolding. After years of fragmentation, opposition figures are suddenly speaking the same language.

"Yes," former Vice President Atiku Abubakar said when asked about reports of an alliance with Labour Party's Peter Obi and ex-Kaduna Governor Nasir El-Rufai. The confirmation, casually dropped during a press briefing in Abuja, sent ripples through the political sphere.

The move, if successful, could mirror the coalition that birthed the APC itself in 2013. But alliances are fragile in Nigeria, often riddled with personal ambitions and ideological contradictions. Still, the opposition is betting on shared frustration—over fuel prices, inflation, and reforms that many say have deepened hardship.

But the presidency is not idly watching. Sources within Aso Rock suggest that strategic talks are ongoing, particularly with governors from the South-East and South-South. The goal? Strike political bargains ahead of 2027—support the president's reelection, and in return, secure their political future.

"You can't ignore the political mathematics of this country," said a senior APC strategist, speaking off record. "We are building bridges—not just within the party, but across it."

And then there's Joe Igbokwe, an unapologetically vocal APC chieftain, whose social media posts often sound like declarations from the inner court.

"There is no vacancy in Aso Rock until President Tinubu completes his second term," he wrote on Facebook, dismissing opposition ambitions with trademark bluntness. "Those of you scheming and dreaming for 2027 should go and rest. Nigeria is being reworked to work again."

It's a sentiment shared by many within the Tinubu administration, who view the current economic turbulence as necessary pain for long-term gain. The removal of fuel subsidies and the unification of exchange rates were bold moves, they argue—meant to stop the financial bleeding caused by decades of mismanagement.

"We know it's tough, but reforms take time," said a senior aide at the Ministry of Finance. "We're not playing politics here. We're rebuilding a broken economy."

Still, outside the gates of Aso Rock, patience is thinning. Markets remain volatile, food prices continue to climb, and many Nigerians feel disconnected from the "Renewed Hope" agenda they once supported. And yet, even amid the growing discontent, the political machine grinds on—quietly, steadily, strategically.

The road to 2027 will not begin with campaign flags or stadium chants. It has already begun—in backroom deals, in WhatsApp group chats between unlikely allies, in the silences between press briefings.

Healthcare in Rural Africa: A Crisis Demanding Collective Action2

Very day across rural Nigeria and Africa, countless lives are lost—not to war or disasters, but to something far more preventable: a lack of basic healthcare access.

In villages tucked away in the heart of Nigeria's vast countryside, people fight for survival against diseases that should not be death sentences. A malaria infection should not claim a child's life. A pregnant woman should not die in labor due to the absence of a skilled health worker. A simple vaccine should not be out of reach for infants. And yet, this is the daily reality for millions.

According to recent studies, an estimated 253,000 people die annually in Nigeria due to inadequate healthcare access. The 2023 report by the Nigerian Primary Health Care Development Agency (NPHCDA) highlights an unsettling truth:

Over 60% of Nigeria's rural population lacks access to functional primary healthcare centers. Many of these facilities are either understaffed or lack basic amenities like electricity, clean water, or essential medicines.

Preventable deaths from malaria, typhoid, and diarrheal diseases remain rampant.

While urban areas witness rapid medical advancements, rural communities are left behind, suffering a silent crisis that continues to claim lives year after year.

The Disturbing Reality of Rural Healthcare

Despite global progress in medicine and technology, Africa—especially rural Nigeria—grapples with healthcare access issues that date back decades. While issues like insecurity, unemployment, and poor infrastructure dominate political discussions, healthcare remains a neglected emergency that affects millions across all demographics.

Nigeria's 2023–24 Demographic and Health Survey (NDHS) presents deeply troubling data on infant and child mortality:

Neonatal mortality (deaths within the first 28 days of life) peaked in Kano, with 59 deaths per 1,000 live births.

Infant mortality (before the first birthday) was highest in Kebbi, reaching 90

deaths per 1,000 live births. Under-5 mortality soared to 161 deaths per 1,000 in Jigawa. These are not just cold statistics. They represent real people—babies, mothers, fathers, families—lost to causes we know how to prevent.

Factors Contributing to the Crisis

1. Lack of Basic Healthcare Infrastructure

Many rural communities do not have functioning hospitals or clinics.

Where facilities exist, they are often:

Underfunded—many have little to no government support. Understaffed—with too few trained health professionals available

Underequipped—lacking essential drugs, ambulances, electricity, and clean water.

2. Cost Barriers: Healthcare Is Too Expensive. Even where healthcare exists, the rural poor simply cannot afford it. With over 40% of Nigerians living below the poverty line, medical expenses often go ignored until an emergency strikes—when it may be toolate

3. Education and Health Awareness

Health isn't just about hospitals—it's about knowledge. Many diseases could be prevented through proper education on:

Nutrition and balanced diets. Basic sanitation and hygiene. The importance of vaccinations.

Family planning and maternal care.

Yet health education is lacking in many rural areas, leading to avoidable deaths.

4. Skilled Healthcare Workers Are Leaving Rural Areas

Doctors and nurses prefer to work in urban areas, where wages are higher and living conditions are better. Thousands migrate abroad, leaving behind critical gaps in the workforce.

Lessons from Successful Global Healthcare Models

Despite these challenges, there are solutions—and we can learn from countries that have successfully improved rural healthcare.

1. Brazil's Family Health Program

A team-based approach, where doctors, nurses, and community health workers are assigned to specific neighborhoods.

Personalized follow-ups ensure early intervention before illness escalates.

2. Rwanda's Community-Based Health Insurance (CBHI)

A government-supported health insurance scheme covering even the poorest citizens.

Funded through government subsidies and community contributions, making healthcare affordable for all.

3. Kenya's Mobile Clinics

Fully equipped mobile clinics travel to remote villages. Doctors visit communities

Urgent Action Needed: What Must Be Done

If Nigeria is to overcome its rural healthcare crisis, we must rethink how we work together:

Invest in primary healthcare centers to ensure basic amenities like electricity, water, and essential medicines.

Expand the healthcare workforce—train and deploy more community health workers.

Leverage technology—telemedicine can connect rural patients to doctors in major hospitals.

Strengthen healthcare education—awareness programs must teach rural f a m i l i e s a b o u t d i s e a s e prevention. Encourage the private sector to commit—beyond donations, businesses must fund long-term healthcare projects.

A Call to Action: Healthcare Must Be a Right, Not a Privilege

This crisis is bigger than statistics. It is about real lives—mothers lost during child-birth, children battling preventable diseases, families suffering in silence because the healthcare system fails them.

We can no longer afford to wait. The time to act is now.

Government, private organizations, community leaders, and individuals all have a role in reversing this crisis.

Policymakers must prioritize healthcare unding.

Healthcare professionals must bring services to rural areas. The private sector must shift from charity to investment.

Every Nigerian must demand better healthcare access. This crisis will not fix itself—but collective action can. Healthcare is not a privilege—it is a fundamental right. It's time to make that a reality.

The Governor, however, directed the Ministry of Women Affairs and Social Development to devise modalities for increased community awareness programmes to educate families and local traditional teachers and guardians on the proper means of enforcing discipline on children.

Meanwhile, Governor Zulum met with the little Bashir Gaji on Sunday at the Government House. He announced that he would provide a fully furnished house for Bukar and his family and a scholarship to cover his education.

"Little Gaji's family currently live in an IDP camp in Monguno after his father was assassinated by Boko Haraminsurgents", it stated.

uper Eagles head coach Eric Chelle has refuted speculation that he secured the Nigerian senior national team job through any form of per-

The Nigeria Football Federation (NFF) appointed Eric Chelle as the new head coach of the Super Eagles, succeeding interim coach Augustine Eguavoen. Eguavoen had successfully led the team to qualify for the 2025 Africa Cup of Nations (AFCON).

In an interview with Brila FM, Eric Chelle emphasized that his appointment as Super Eagles coach was transparent and meritbased. He revealed that he applied for the position through a formal process, just like call for applications from the NFF, from the Nigerian Federation and so I applied like any other coach and then interview came, "Chelle explained.

Eric Chelle further explained the appointment process, highlighting that he presented his footballing ideas and vision as part of the selection process.

"I was invited to a coaches' conference where I presented my project, my vision, and philosophy," Eric Chelle explained. He added that although he initially thought the process would move faster, delays occurred, and he had to wait. Despite leaving for Rouen, he returned when the opportunity resurfaced, eager to take on the significant project of leading the Super Eagles.

Chelle secured four points in his first two games as Super Eagles coach, with a 2-0 win against Rwanda and a 1-1 draw with Zimbabwe in World Cup qualifiers.
